1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. [161.375] COST PARTICIPATION.
1.7	Subdivision 1. Cost participation limitations. (a) Cost participation policies and
1.8	procedures established by the commissioner for trunk highway projects must not require or
1.9	obligate a local unit of government to pay for any portion of the project costs that are:
1.10	(1) incurred within a trunk highway right-of-way; and
1.11	(2) necessitated as a result of the project.
1.12	(b) Project costs under this subdivision include but are not limited to utility relocation.
1.13	(c) The requirements under this subdivision apply regardless of facility ownership,
1.14	whether an expenditure is for a nontrunk highway purpose that must not be paid from the
1.15	trunk highway fund, or whether the project provides for nontrunk highway system benefits.
1.16	The commissioner must identify nontrunk highway fund sources as necessary.
1.17	Subd. 2. Application. The requirements under subdivision 1 do not apply to costs that
