44.11 \$250,000 in fiscal year 2020 is appropriated from the arts and cultural heritage fund to  
44.12 the commissioner of administration to be transferred to the Medal of Honor account to  
44.13 complete design and construction of a memorial in the Capitol area to honor all Minnesota  
44.14 Medal of Honor recipients. This appropriation is a replacement for the appropriation in  
44.15 Laws 2017, chapter 91, article 4, section 2, subdivision 6, paragraph (p), that canceled at  
44.16 the close of fiscal year 2019.

44.17 **EFFECTIVE DATE.** This section is effective the day following final enactment."
