1.3 "Section 1. Minnesota Statutes 2016, section 120B.11, subdivision 1, is amended to read:

1.4 Subdivision 1. **Definitions.** For the purposes of this section and section 120B.10, the  
1.5 following terms have the meanings given them.

1.6 (a) "Instruction" means methods of providing learning experiences that enable a student  
1.7 to meet state and district academic standards and graduation requirements including applied  
1.8 and experiential learning.

1.9 (b) "Curriculum" means district or school adopted programs and written plans for  
1.10 providing students with learning experiences that lead to expected knowledge and skills  
1.11 and career and college readiness.

1.12 (c) "World's best workforce" means striving to: meet school readiness goals; have all  
1.13 third grade students achieve grade-level literacy; close the academic achievement gap among  
1.14 all racial and ethnic groups of students and between students living in poverty and students  
1.15 not living in poverty; have all students attain career and college readiness before graduating  
1.16 from high school; and have all students graduate from high school.

1.17 (d) "Experiential learning" means learning for students that includes career exploration  
1.18 through a specific class or course or through work-based experiences such as job shadowing,  
1.19 mentoring, entrepreneurship, service learning, volunteering, internships, other cooperative  
1.20 work experience, youth apprenticeship, or employment.

1.21 (e) "State plan" means the plan submitted by the commissioner in accordance with the  
1.22 Elementary and Secondary Education Act, as most recently authorized, and approved by  
1.23 the United States Department of Education, including state goals.

2.1 (f) "Ineffective teacher" means a teacher whose most recent summative teacher evaluation  
2.2 resulted in placing or otherwise keeping the teacher on an improvement process pursuant  
2.3 to section 122A.40, subdivision 8, or section 122A.41, subdivision 5.

2.4 (g) "Inexperienced teacher" means a licensed teacher who has been employed as a teacher  
2.5 for three years or less.

2.6 (h) "Out-of-field teacher" means a licensed teacher who is providing instruction in an  
2.7 area in which he or she is not licensed.

2.9 Subd. 1a. **Performance measures.** Measures to determine school district and school  
2.10 site progress in striving to create the world's best workforce must include at least:

2.11 (1) the size of the academic achievement gap as measured on the Minnesota  
2.12 Comprehensive Assessments, rigorous course taking under section 120B.35, subdivision  
2.13 3, paragraph (c), clause (2), and enrichment experiences by student subgroup;

2.14 (2) student performance on the Minnesota Comprehensive Assessments in reading and  
2.15 mathematics;

2.16 (3) high school graduation rates; ~~and~~

2.17 (4) career and college readiness under section 120B.30, subdivision 1, paragraph (p),  
2.18 as measured by student performance on the high school Minnesota Comprehensive  
2.19 Assessments in reading and mathematics; and

2.20 (5) performance measures consistent with the state plan, not otherwise required by this  
2.21 subdivision.

2.22 Sec. 3. Minnesota Statutes 2016, section 120B.11, subdivision 2, is amended to read:

2.23 Subd. 2. **Adopting plans and budgets.** A school board, at a public meeting, shall adopt  
2.24 a comprehensive, long-term strategic plan to support and improve teaching and learning  
2.25 that is aligned with creating the world's best workforce and includes:

2.26 (1) clearly defined district and school site ~~goals and benchmarks for~~ toward meeting  
2.27 statewide goals for instruction and student achievement for all student subgroups identified  
2.28 in section 120B.35, subdivision 3, paragraph (b), clause (2);

2.29 (2) a process to assess and evaluate each student's progress toward meeting state and  
2.30 local academic standards, assess and identify students to participate in gifted and talented  
2.31 programs and accelerate their instruction, and adopt early-admission procedures consistent

3.1 with section 120B.15, and identifying the strengths and weaknesses of instruction in pursuit  
3.2 of student and school success and curriculum affecting students' progress and growth toward  
3.3 career and college readiness and leading to the world's best workforce;

3.4 (3) a system to periodically review and evaluate the effectiveness of all instruction and  
3.5 curriculum, taking into account strategies and best practices, student outcomes, school

3.7 teachers who are members of populations underrepresented among the licensed teachers in  
3.8 the district or school and who reflect the diversity of enrolled students under section 120B.35,

3.22 Subd. 5. **Report.** ~~Consistent with requirements for school performance reports under~~  
3.23 ~~section 120B.36, subdivision 1, the school board shall publish a report in the local newspaper~~  
3.24 ~~with the largest circulation in the district, by mail, or by electronic means on the district~~  
3.25 ~~Web site.~~ (a) The school board shall must hold an annual public meeting to review, and  
3.26 revise where appropriate, student achievement goals, local assessment outcomes, plans,  
3.27 strategies, and practices for improving curriculum and instruction and cultural competency,  
3.28 and efforts to equitably distribute diverse, effective, experienced, and in-field teachers, and  
3.29 to review district success in realizing the previously adopted student achievement goals and  
3.30 related benchmarks and the improvement plans leading to the world's best workforce. The  
3.31 school board must transmit an electronic summary of its report to the commissioner in the

4.8 Subd. 9. **Annual evaluation.** (a) The commissioner must identify effective strategies,  
4.9 practices, and use of resources by districts and school sites in striving for the world's best  
4.10 workforce. The commissioner must assist districts and sites throughout the state in  
4.11 implementing these effective strategies, practices, and use of resources.

4.12 (b) The commissioner must use the performance measures in subdivision 1a to identify  
4.13 ~~those districts in any consecutive three-year period~~ and school sites not making sufficient  
4.14 progress in any consecutive three-year period toward ~~improving teaching and learning~~  
4.15 meeting performance goals for all students, including English learners with varied needs,  
4.16 consistent with section 124D.59, subdivisions 2 and 2a, and striving for the world's best  
4.17 workforce.

4.18 (c) The commissioner, in collaboration with the identified district, may require the district
