1.7 direction to a point on ~~Route No. 153 as herein established at or near Ashby, thence extending~~  
1.8 ~~in a northeasterly direction to a point on~~ Route No. 181 as herein established at or near

1.16 work, and without advertising for bids or otherwise complying with the requirements of  
1.17 competitive bidding if the total contractual obligation of the state for the directly negotiated  
1.18 contract or contracts on any single project does not exceed ~~\$150,000~~ \$250,000. All quotations  
1.19 obtained shall be kept on file for a period of at least one year after receipt of the quotation."

2.3 Subd. 11. **Automobile transporter.** (a) For purposes of this subdivision, the following  
2.4 terms have the meanings given them:

2.5 (1) "automobile transporter" means any vehicle combination designed and used to  
2.6 transport assembled highway vehicles, including truck camper units;

2.7 (2) "stinger-steered combination automobile transporter" means a truck tractor semitrailer  
2.8 having the fifth wheel located on a drop frame located behind and below the rear-most axle  
2.9 of the power unit; and

2.10 (3) "backhaul" means the return trip of a vehicle transporting cargo or general freight,  
2.11 including when carrying goods back over all or part of the same route.

2.12 (b) Stinger-steered combination automobile transporters having a length of 80 feet or  
2.13 less may be operated on interstate highways and other highways designated in this section,  
2.14 and in addition may carry a load that extends the length by four feet or less in the front of  
2.15 the vehicle and six feet or less in the rear of the vehicle.

2.16 (c) An automobile transporter may transport cargo or general freight on a backhaul,  
2.17 provided it complies with weight limitations for a truck tractor and semitrailer combination

2.21 Subd. 2. **Conditions.** (a) A vehicle or combination of vehicles described in subdivision  
2.22 1 must:

2.23 (1) comply with seasonal load restrictions in effect between the dates set by the  
2.24 commissioner under section 169.87, subdivision 2;

2.25 (2) comply with bridge load limits posted under section 169.84;

2.26 (3) be equipped and operated with six or more axles and brakes on all wheels;

2.27 (4) not exceed 90,000 pounds gross vehicle weight, or 99,000 pounds gross vehicle  
2.28 weight during the time when seasonal increases are authorized under section 169.826;

2.29 (5) not be operated on interstate highways;

2.30 (6) obtain an annual permit from the commissioner of transportation;

3.11 Subd. 4. **Certain emergency vehicles.** (a) The provisions of sections 169.80 to 169.88  
3.12 governing size, weight, and load do not apply to a fire apparatus, a law enforcement special  
3.13 response vehicle, or a licensed land emergency ambulance service vehicle.

3.14 (b) Emergency vehicles designed to transport personnel and equipment to support the  
3.15 suppression of fires and to mitigate other hazardous situations are subject to the following  
3.16 weight limitations when operated on an interstate highway:

3.17 (1) 24,000 pounds on a single steering axle;

3.18 (2) 33,500 pounds on a single drive axle;

3.19 (3) 52,000 pounds on a tandem rear drive steer axle; and

3.20 (4) 62,000 pounds on a tandem axle. The gross weight of an emergency vehicle operating  
3.21 on an interstate highway must not exceed 86,000 pounds."

3.26 **road maintenance.** (a) Sections 574.26 to 574.32 do not apply to a manufacturer of public  
3.27 transit buses that manufactures at least 100 public transit buses in a calendar year. For  
3.28 purposes of this section, "public transit bus" means a motor vehicle designed to transport  
3.29 people, with a design capacity for carrying more than 40 passengers, including the driver.

4.1 The term "public transit bus" does not include a school bus, as defined in section 169.011,  
4.2 subdivision 71.

4.3 (b) At the discretion of the commissioner of transportation, sections 574.26 to 574.32  
4.4 do not apply to any projects of the Department of Transportation (1) costing less than the
