1.3 Page 5, after line 16, insert:

1.4 "(f) Fusion Center Report

1.5 (a) The Criminal and Juvenile Justice
1.6 Information and Bureau of Criminal
1.7 Apprehension Advisory Group and the
1.8 commissioner shall prepare an annual report
1.9 for the public and the legislature on the
1.10 Minnesota Fusion Center (MNFC). The report
1.11 must include the following information:

1.12 (1) the number of Suspicious Activity Reports
1.13 (SARs) received and processed by the MNFC
1.14 during the preceding calendar year; including
1.15 the agencies where they were submitted
1.16 originated from;

1.17 (2) the number of SARs received and
1.18 processed by the MNFC that result in the
1.19 initiation or enhancement of an investigation
1.20 by the Federal Bureau of Investigation or local
1.21 law enforcement agencies;

1.22 (3) the number of SARs processed and
1.23 submitted by the MNFC that involve an
1.24 individual on the Terrorist Screening Center
1.25 watchlist or MNFC's watchlist where a

2.1 reasonable suspicious standard has been met,
2.2 this may include for criminal investigation or
2.3 terrorism activities;

2.4 (4) the number of MNFC tips and leads
2.5 received and processed by the MNFC, and
2.6 also the number that were provided to other
2.7 law enforcement agencies for follow up action
2.8 during the preceding calendar year;

2.9 (5) the number of requests for information
2.10 (RFI) that the MNFC received from law
2.11 enforcement agencies and the number of
2.12 responses to federal requests for RFIs during
2.13 the preceding calendar year;

2.14 (6) the number of arrests and prosecutions that
2.15 resulted from the MNFC's use of SARs,
2.16 MNFC tips and leads, during the preceding
2.17 calendar year;

2.18 (7) the number and types of criminal activities
2.19 that were stopped or hindered by the MNFC's
2.20 activities during the preceding calendar year;

2.21 (8) the number of publications such as
2.22 risk/threat assessments, and operational
2.23 reports. Also provide a general review of what
2.24 these publications were;

2.25 (9) the MNFC's operating budget and number
2.26 of staff and their duties for the preceding
2.27 calendar year;

2.28 (10) surveillance and data analysis
2.29 technologies, such as artificial intelligence or
2.30 social media analysis, utilized by the MNFC
2.31 during the preceding calendar year;

3.1 (11) the names of the federal agencies the
3.2 MNFC received data from or shared data with
3.3 during the preceding calendar year;

3.4 (12) a description of the commercial and
3.5 governmental databases utilized by the MNFC
3.6 during the preceding calendar year;

3.7 (13) number of data requests responded to by
3.8 the MNFC and general description of those
3.9 requests;

3.10 (14) summary of audit findings for which
3.11 fusion centers, subjects of those audits, and
3.12 what corrective actions were taken;

3.13 (15) description of activities of the previous
3.14 year of the MNFC's activities with the Joint
3.15 Terror Task Force; and

3.16 (16) any other data relevant to the MNFC's
3.17 operations during the preceding calendar year,
3.18 as determined by the Criminal and Juvenile
3.19 Justice Information and Bureau of Criminal
3.20 Apprehension Advisory Group.

3.21 (b) The initial report shall be provided to the
3.22 chairs and ranking minority members of the
3.23 committees of the house of representatives
3.24 and senate with jurisdiction over data practices
3.25 and public safety issues, and shall be posted
3.26 on the MNFC website by February 15, 2023.
3.27 Subsequent reports must be submitted by
3.28 February 15 each year."
