Chair Igo withdrew A3 amendment to the DE2 amendment to HF 1141.

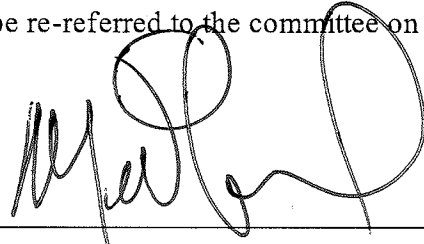
