2.5 use path unless the local authority or state agency having jurisdiction over the bicycle path
2.6 or trail prohibits the operation.

2.7 (d) The local authority or state agency having jurisdiction over a trail or over a bike park
2.8 that is designated as nonmotorized and that has a natural surface tread made by clearing
2.9 and grading the native soil with no added surfacing materials may regulate the operation of
2.10 an electric-assisted bicycle.
