Bill Description

Section 1 clarifies that children can reside in a residential hospice, and broadens the definition of hospice services to include children needing respite care or palliative care who have a shortened life expectancy.

Section 2 clarifies the definition of respite care.

Assumptions

The Health Regulation Division of the Minnesota Department of Health licenses and inspects hospice facilities as the routine course of its business. MDH is aware of one new provider-licensee under this new provision because services like these for children are so unique and the facility would not be reimbursed under federal Medicare as is typical for hospice providers. Minnesota state hospice license fees are annual and Minnesota statute has a 14 tier system for the license fees based on annual revenues. For purposes of this fiscal note, we assumed the highest license fee tier amount, however, depending on the actual provider's license application and its annual revenues, the license fee amount could be less.

It is presumed that one additional facility will be licensed under this bill, paying the annual licensing fee of \$5,000.

It is presumed that this facility will be inspected. It is projected that this will take 36 hours a year of nurse evaluator inspections time or .02 FTE. This will also require .01 FTE of supervisor time and .01 FTE of OAS support time. Costs also include commensurate travel, communications, supplies and computer costs.
