10.29 Subdivision 1. Definitions. (a) For the purposes of this act, "distance learning period"
10.30 means March 18, 2020, through May 4, 2020, or later, if extended by emergency executive
10.31 order.

11.1 (b) For the purposes of this section, a "school district" includes a cooperative unit under
11.2 Minnesota Statutes, section 123A.24, subdivision 2, that serves students on site.

11.3 Subd. 2. **Distance learning period; employees.** (a) This subdivision applies to an
11.4 employee of a school district or charter school, during the distance learning period, who:

11.5 (1) was scheduled to work during the distance learning period;

11.6 (2) did not work on a scheduled day or worked fewer than the number of scheduled
11.7 hours for the employee that day; and

11.8 (3) did not receive compensation for all scheduled hours that day.

11.9 (b) In addition to paragraph (a), this subdivision applies to any day or portion of a day
11.10 not worked, during which the employee was scheduled to work, that the employee did not
11.11 work at the recommendation or direction of a health care provider acting within the provider's
11.12 scope of practice or a Department of Health staff member due to the possibility the employee
11.13 was exposed to or infected with COVID-19.

11.14 (c) Notwithstanding any law to the contrary, for each day or portion of a day identified
