This bill allows licensed traditional midwives to obtain and possess, in addition to administer, certain medications. The bill also provides licensed traditional midwives the ability to directly obtain certain supplies and devices, administer drugs and diagnostic tests, order rests and receive reports.

Bill Description

Clarifies licensed traditional midwife (LTM) authority to obtain, possess, and administer certain drugs, supplies, and devices; amending Minnesota Statutes 2022, sections 147D.09; 151.37

Assumptions

This bill clarifies the LTM authority within their own statute 147D.09 and excludes LTM's from MN Stat. 151.37 that defines who may prescribe and possess legend drugs. All complaints related to LTM's received by the Board of Pharmacy would be forwarded to the Board of Medical Practice as the BMP has jurisdiction over the LTM's and their scope of practice.
