1.4 "Sec. Minnesota Statutes 2022, section 144.1464, subdivision 1, is amended to read:

1.5 Subdivision 1. **Summer internships.** The commissioner of health, through a contract
1.6 with a nonprofit organization as required by subdivision 4, shall award grants, within
1.7 available appropriations, to hospitals, clinics, nursing facilities, assisted living facilities,
1.8 and home care providers to establish a secondary and postsecondary summer health care
1.9 intern program. The purpose of the program is to expose interested secondary and
1.10 postsecondary pupils to various careers within the health care profession.

1.11 Sec. Minnesota Statutes 2022, section 144.1464, subdivision 2, is amended to read:

1.12 Subd. 2. **Criteria.** (a) The commissioner, through the organization under contract, shall
1.13 award grants to hospitals, clinics, nursing facilities, assisted living facilities, and home care
1.14 providers that agree to:

1.15 (1) provide secondary and postsecondary summer health care interns with formal exposure
1.16 to the health care profession;

1.17 (2) provide an orientation for the secondary and postsecondary summer health care
1.18 interns;

1.19 (3) pay one-half the costs of employing the secondary and postsecondary summer health
1.20 care intern;

1.21 (4) interview and hire secondary and postsecondary pupils for a minimum of six weeks
1.22 and a maximum of 12 weeks; and

2.1 (5) employ at least one secondary student for each postsecondary student employed, to
2.2 the extent that there are sufficient qualifying secondary student applicants.

2.3 (b) In order to be eligible to be hired as a secondary summer health intern by a hospital,
2.4 clinic, nursing facility, assisted living facility, or home care provider, a pupil must:

2.5 (1) intend to complete high school graduation requirements and be between the junior
2.6 and senior year of high school; and

2.7 (2) be from a school district in proximity to the facility.

2.8 (c) In order to be eligible to be hired as a postsecondary summer health care intern by
2.9 a hospital or clinic, a pupil must:

2.10 (1) intend to complete a health care training program or a two-year or four-year degree
2.11 program and be planning on enrolling in or be enrolled in that training program or degree
2.12 program; and

2.13 (2) be enrolled in a Minnesota educational institution or be a resident of the state of
2.14 Minnesota; priority must be given to applicants from a school district or an educational
2.15 institution in proximity to the facility.

2.16 (d) Hospitals, clinics, nursing facilities, assisted living facilities, and home care providers
2.17 awarded grants may employ pupils as secondary and postsecondary summer health care
2.18 interns ~~beginning on or after June 15, 1993~~, if they agree to pay the intern, during the period
2.19 before disbursement of state grant money, with money designated as the facility's 50 percent
2.20 contribution towards internship costs.

2.21 Sec. Minnesota Statutes 2022, section 144.1464, subdivision 3, is amended to read:

2.22 Subd. 3. **Grants.** The commissioner, through the organization under contract, shall
2.23 award separate grants to hospitals, clinics, nursing facilities, assisted living facilities, and
2.24 home care providers meeting the requirements of subdivision 2. The grants must be used
2.25 to pay one-half of the costs of employing secondary and postsecondary pupils in a hospital,
2.26 clinic, nursing facility, assisted living facility, or home care setting during the course of the
2.27 program. No more than 50 percent of the participants may be postsecondary students, unless
2.28 the program does not receive enough qualified secondary applicants per fiscal year. No
2.29 more than five pupils may be selected from any secondary or postsecondary institution to
2.30 participate in the program and no more than one-half of the number of pupils selected may
2.31 be from the seven-county metropolitan area."
