## **Bill Description**

This bill increases the possible Housing Support base (room and board) rate for the approximately 3,000 individuals who have experienced long-term homelessness and reside in certain settings. The agency may increase the room and board rate for recipients impacted by this section by \$50 per month.

This bill also appropriates \$2,000,000 from the general fund for adult mental health grants under Minnesota Statutes, section 245.4661, subdivision 9, paragraph (a), clause (2), to support increased availability of housing with supports for adults with serious mental illness.

### Assumptions

The effective date of the bill is November 1, 2018.

The primary fiscal impact of this bill is increased Housing Support (HS) payments. DHS data for SFY17 show that there are 2,691 average monthly HS recipients who meet the criteria - individuals who have experienced long-term homelessness and are in supportive housing settings - and HS payment is estimated to increase by \$50 per person per month under the new bill.

Projected annual growth in the number of recipients is based on an actual average annual growth of 9% over the period of 2015-2017.

This legislation would require a change to existing IT processes. The programming changes required to identify this specific group of Housing Support recipients necessitates an effective date of November 1, 2018.
