HF 526 (Agbaje) A bill for an act relating to taxation; allowing certain single-member LLCs to claim income tax credits for income taxes paid to other states; modifying the exemption for certain sales of property used in a trade or business; amending Minnesota Statutes 2022, sections 290.06, subdivision 22; 297A.68, subdivision 25.

Representative Agbaje moved that HF 256 be laid over for possible inclusion in the Taxes Omnibus bill.

Representative Agbaje moved the H0526A1 amendment. THE MOTION PREVAILED. THE AMENDMENT WAS ADOPTED.

HF 810 (Brand) A bill for an act relating to taxation; individual income; providing a refundable credit for investments in energy efficient home improvements, electric vehicles, and renewable energy; appropriating money; proposing coding for new law in Minnesota Statutes, chapter 290.

Representative Brand moved that HF 810 be laid over for possible inclusion in the Taxes Omnibus bill.

Representative Brand moved the H0810A3 amendment. THE MOTION PREVAILED. THE AMENDMENT WAS ADOPTED.
