I represent The Equity Advantage (TEA), a nonprofit organization that strives to make the world more equitable and just. Our staff have had the privilege of advising and collaborating with many of the world's most extraordinary social change leaders including legislatures and impact leaders. I am writing on behalf of my colleagues at TEA, all our State and national clients, our community and corporate partners, and the multiple families that communicated with us on this issue.

We support this bill because it makes a distinction between folks who have willfully been irresponsible with their driving privileges and those who truly deserve to have them because their debt to society has been paid. The Reintegration Driver's License creates an opportunity for individuals in the latter case who have served their time to make a fresh start. By approving this bill, you will be:

- ✓ contributing to public safety because it creates a strong incentive to avoid new violations that would lead to a cancellation of the license
- ✓ sending a strong signal that the purpose of the criminal justice system is to rehabilitate and not just to punish
- ✓ reducing the burden on taxpayers by reducing recidivism, benefits employers in a time when reliable employees are an employer's biggest asset – and most important, it reaffirms the humanity of the individual, the possibility for change, and the hope for a better future.
