

1.1 ..... moves to amend H.F. No. 3, the second engrossment, as follows:

1.2 Page 21, delete subdivision 4 and insert:

1.3 "Subd. 4. **Optional early reissuance and expiration date extension.** (a) For purposes  
1.4 of this subdivision, "full compliance date" means the date when full compliance with the  
1.5 REAL ID Act is required and no extensions are in effect for federal acceptance of  
1.6 Minnesota-issued licenses and identification cards for official purposes, as most recently  
1.7 specified by the United States Department of Homeland Security under Code of Federal  
1.8 Regulations, title 6, part 37.

1.9 (b) For purposes of this subdivision, "eligible applicant" means an applicant for a REAL  
1.10 ID-compliant driver's license or identification card who:

1.11 (1) holds a valid Minnesota driver's license or Minnesota identification card that:

1.12 (i) was issued prior to the date Minnesota commenced issuing REAL ID-compliant  
1.13 licenses and Minnesota identification cards; and

1.14 (ii) either (A) has an expiration date that is after the full compliance date; or (B) does  
1.15 not have an expiration date as provided under Minnesota Statutes, section 171.07, subdivision  
1.16 4;

1.17 (2) submits the license or identification card application no later than one year following  
1.18 the full compliance date; and

1.19 (3) is otherwise eligible to obtain the license or identification card under Minnesota  
1.20 Statutes, chapter 171.

1.21 (c) For the first instance of issuing a REAL ID-compliant driver's license to an eligible  
1.22 applicant, the expiration date as provided in Minnesota Statutes, section 171.27, paragraph  
1.23 (a), is extended by two years, notwithstanding the requirements of that section.

2.1 (d) For the first instance of issuing a REAL ID-compliant identification card to an eligible  
2.2 applicant, the expiration date as provided in Minnesota Statutes, section 171.07, subdivision  
2.3 4, paragraph (a), is extended by two years, notwithstanding the requirements of that section.

2.4 (e) The expiration date extension under paragraphs (c) and (d) does not apply to:

2.5 (1) issuance of a new driver's license or Minnesota identification card;

2.6 (2) issuance or renewal of a noncompliant license or identification card, as defined in  
2.7 Minnesota Statutes, section 171.01, subdivision 41a;

2.8 (3) issuance or renewal of an enhanced driver's license or enhanced identification card;

2.9 (4) reinstatement of a canceled, suspended, or revoked license;

2.10 (5) a driver's license subject to Minnesota Statutes, section 171.27, paragraphs (b) to  
2.11 (d); and

2.12 (6) a Minnesota identification card subject to Minnesota Statutes, section 171.07,  
2.13 subdivision 4, paragraphs (b) to (e)."
