**Bill Description**

The proposed bill will amend the Minnesota Statutes 2018, section 190.16, subdivision 6a to allow The Adjutant General or The Adjutant General's designee to rent other Military Department facilities such as armories, buildings, or another facilities operated and maintained by The Adjutant General. Also, when The Adjutant General authorizes the rental of an armory, a building, or a facility, the Adjutant General may order to temporary state active service, with their consent, current or former officers, warrant officers, and enlisted personnel of the National Guard of the state to ensure safe operation and usage of the armory, building, or facility. This service does not accrue rights under any other subdivision. The rate of pay for those personnel in temporary state active service in support of a rental under this subdivision shall be in accordance with rates and policies established by The Adjutant General. The Adjutant General shall ensure that the cost of such personnel is included in the terms of the rental agreement for the armory, building, or facility.

**Assumptions**

Administrative costs to manage the proposed bill will be negligible. Rental rates will be calculated to cover any increased utilities, maintenance, personnel and other costs directly attributable to the rental.
