1.10 \$750, for the purpose of bringing about the individual's nomination or election. A candidate
1.11 remains a candidate until the candidate's principal campaign committee is dissolved as
1.12 provided in section 10A.243.

1.14 Subd. 6a. **Place of filing.** A public official required to file a statement under this section

1.17 member of the Metropolitan Council must file the statement with the board. The governing
1.18 body must maintain statements filed with it under this subdivision as public data. If an
1.19 official position is defined as both a public official and as a local official of a metropolitan
