1.14 **ECONOMIC ASSISTANCE**

1.15 Section 1. Minnesota Statutes 2024, section 142A.03, is amended by adding a subdivision
1.16 to read:

1.17 Subd. 35. **Electronic benefits transfer; contracting and procurement.** Notwithstanding
1.18 chapter 16C, the commissioner is exempt from the contract term limits for the issuance of
1.19 public benefits through an electronic benefit transfer system and related services. These
1.20 contracts may have up to an initial five-year term, with extensions not to exceed a ten-year
1.21 total contract duration.

1.22 **ARTICLE 2**
1.23 **CHILD PROTECTION AND WELFARE POLICY**

1.24 Section 1. Minnesota Statutes 2024, section 142B.01, subdivision 15, is amended to read:

1.25 Subd. 15. **Individual who is related.** "Individual who is related" means a spouse, a
1.26 parent, a birth or adopted child or stepchild, a stepparent, a stepbrother, a stepsister, a niece,

2.1 a nephew, an adoptive parent, a grandparent, a sibling, an aunt, an uncle, or a legal guardian.
 2.2 For purposes of family child foster care, individual who is related also includes an individual
 2.3 who, prior to the child's placement in the individual's home for foster care or adoption, was
 2.4 an important friend of the child or of the child's parent or custodian, including an individual
 2.5 with whom the child has resided or had significant contact or who has a significant
 2.6 relationship to the child or the child's parent or custodian.

2.7 Sec. 2. Minnesota Statutes 2024, section 142B.05, subdivision 3, is amended to read:

2.8 Subd. 3. **Foster care by an individual who is related to a child; license required.** (a)
 2.9 Notwithstanding subdivision 2, paragraph (a), clause (1), in order to provide foster care for
 2.10 a child, an individual who is related to the child, other than a parent, or legal guardian, must
 2.11 be licensed by the commissioner except as provided by section 142B.06.

2.12 (b) An individual who is related to the child may seek foster care licensure through the
 2.13 county agency or a private agency in the community designated or licensed by the
 2.14 commissioner. The county agency must provide information to all potential relative foster
 2.15 care providers about this choice. Counties are not obligated to pay costs for services provided
 2.16 by private agencies.

2.17 (c) If an individual who is related to a child is seeking licensure to provide foster care
 2.18 for the child and the individual has a domestic partner but is not married to the domestic
 2.19 partner, only the individual related to the child must be licensed to provide foster care. The
 2.20 commissioner must conduct background studies on household members according to section
 2.21 245C.03, subdivision 1.

2.22 Sec. 3. Minnesota Statutes 2024, section 142B.47, is amended to read:

2.23 **142B.47 TRAINING ON RISK OF SUDDEN UNEXPECTED INFANT DEATH**
 2.24 **AND ABUSIVE HEAD TRAUMA FOR CHILD FOSTER CARE PROVIDERS.**

2.25 (a) Licensed child foster care providers, except individuals related to the child, that care
 2.26 for infants or children through five years of age must document that before caregivers assist
 2.27 in the care of infants or children through five years of age, ~~they~~ the caregivers are instructed
 2.28 on the standards in section 142B.46 and receive training on reducing the risk of sudden
 2.29 unexpected infant death and abusive head trauma from shaking infants and young children.
 2.30 Licensed child foster care providers who are related to the child and who only serve a relative
 2.31 child must document completion of the training required under this section within 30 days
 2.32 after licensure. This section does not apply to emergency relative placement under section

3.1 142B.06. The training on reducing the risk of sudden unexpected infant death and abusive
3.2 head trauma may be provided as:

3.3 (1) orientation training to child foster care providers who care for infants or children
3.4 through five years of age under Minnesota Rules, part 2960.3070, subpart 1; or

3.5 (2) in-service training to child foster care providers who care for infants or children
3.6 through five years of age under Minnesota Rules, part 2960.3070, subpart 2.

3.7 (b) Training required under this section must be at least one hour in length and must be
3.8 completed at least once every five years. At a minimum, the training must address the risk
3.9 factors related to sudden unexpected infant death and abusive head trauma, means of reducing
3.10 the risk of sudden unexpected infant death and abusive head trauma, and license holder
3.11 communication with parents regarding reducing the risk of sudden unexpected infant death
3.12 and abusive head trauma.

3.13 (c) Training for child foster care providers must be approved by the county or private
3.14 licensing agency that is responsible for monitoring the child foster care provider under
3.15 section 142B.30. The approved training fulfills, in part, training required under Minnesota
3.16 Rules, part 2960.3070.

3.17 Sec. 4. Minnesota Statutes 2024, section 142B.51, subdivision 2, is amended to read:

3.18 Subd. 2. **Child passenger restraint systems; training requirement.** (a) Programs
3.19 licensed by the Department of Human Services under chapter 245A or the Department of
3.20 Children, Youth, and Families under this chapter and Minnesota Rules, chapter 2960, that
3.21 serve a child or children under eight years of age must document training that fulfills the
3.22 requirements in this subdivision.

3.23 (b) Before a license holder, staff person, or caregiver transports a child or children under
3.24 age eight in a motor vehicle, the person transporting the child must satisfactorily complete
3.25 training on the proper use and installation of child restraint systems in motor vehicles.
3.26 Training completed under this section may be used to meet initial or ongoing training under
3.27 Minnesota Rules, part 2960.3070, subparts 1 and 2.

3.28 (c) Training required under this section must be completed at orientation or initial training
3.29 and repeated at least once every five years. At a minimum, the training must address the
3.30 proper use of child restraint systems based on the child's size, weight, and age, and the
3.31 proper installation of a car seat or booster seat in the motor vehicle used by the license
3.32 holder to transport the child or children.

4.1 (d) Training under paragraph (c) must be provided by individuals who are certified and
4.2 approved by the Office of Traffic Safety within the Department of Public Safety. License
4.3 holders may obtain a list of certified and approved trainers through the Department of Public
4.4 Safety website or by contacting the agency.

4.5 (e) Notwithstanding paragraph (a), for an emergency relative placement under section
4.6 142B.06, the commissioner may grant a variance to the training required by this subdivision
4.7 for a relative who completes a child seat safety check up. The child seat safety check up
4.8 trainer must be approved by the Department of Public Safety, Office of Traffic Safety, and
4.9 must provide one-on-one instruction on placing a child of a specific age in the exact child
4.10 passenger restraint in the motor vehicle in which the child will be transported. Once granted
4.11 a variance, and if all other licensing requirements are met, the relative applicant may receive
4.12 a license and may transport a relative foster child younger than eight years of age. A child
4.13 seat safety check up must be completed each time a child requires a different size car seat
4.14 according to car seat and vehicle manufacturer guidelines. A relative license holder must
4.15 complete training that meets the other requirements of this subdivision prior to placement
4.16 of another foster child younger than eight years of age in the home or prior to the renewal
4.17 of the child foster care license.

4.18 (f) Notwithstanding paragraph (b), a child foster care license holder who is an individual
4.19 related to the child and who only serves a relative child must document completion of the
4.20 training required under this section within 30 days after licensure.

4.21 Sec. 5. Minnesota Statutes 2024, section 142B.80, is amended to read:

4.22 **142B.80 CHILD FOSTER CARE TRAINING REQUIREMENT; MENTAL**
4.23 **HEALTH TRAINING; FETAL ALCOHOL SPECTRUM DISORDERS TRAINING.**

4.24 Prior to a nonemergency placement of a child in a foster care home, the child foster care
4.25 license holder and caregivers in foster family and treatment foster care settings must complete
4.26 two hours of training that addresses the causes, symptoms, and key warning signs of mental
4.27 health disorders; cultural considerations; and effective approaches for dealing with a child's
4.28 behaviors. At least one hour of the annual training requirement for the foster family license
4.29 holder and caregivers must be on children's mental health issues and treatment. Except for
4.30 providers and services under chapter 245D and child foster care license holders who are
4.31 individuals related to the child and who only serve a relative child who does not have fetal
4.32 alcohol spectrum disorder, the annual training must also include at least one hour of training
4.33 on fetal alcohol spectrum disorders, which must be counted toward the 12 hours of required
4.34 in-service training per year. Short-term substitute caregivers are exempt from these

5.1 requirements. Training curriculum shall be approved by the commissioner of children,
5.2 youth, and families.

5.3 **Sec. 6. [142B.81] CHILD FOSTER CARE TRAINING; RELATIVE CAREGIVERS.**

5.4 Notwithstanding the required hours under Minnesota Rules, part 2960.3070, subpart 2,
5.5 a child foster care license holder who is an individual related to the child must complete a
5.6 minimum of six hours of in-service training per year in one or more of the areas in Minnesota
5.7 Rules, part 2960.3070, subpart 2, or in other areas as agreed upon by the licensing agency
5.8 and the foster parent. The relative child foster care license holder must consult with the
5.9 licensing agency and complete training in areas that are most applicable to caring for the
5.10 relative children in foster care in the home. This section does not apply to a child foster care
5.11 license holder who is licensed to care for both a relative child and a nonrelative child.

5.12 Sec. 7. Minnesota Statutes 2024, section 245C.02, is amended by adding a subdivision to
5.13 read:

5.14 Subd. 16b. **Relative.** "Relative" has the meaning given in section 260C.007, subdivision
5.15 27. For purposes of background studies affiliated with child foster care licensure, a person
5.16 is a relative if the person was known to the child or the child's parent before the child is
5.17 placed in foster care.

5.18 Sec. 8. Minnesota Statutes 2024, section 260.65, is amended to read:

5.19 **260.65 NONCUSTODIAL PARENTS; RELATIVE PLACEMENT.**

5.20 (a) Prior to the removal of an African American or a disproportionately represented child
5.21 from the child's home, the responsible social services agency must make active efforts to
5.22 identify and locate the child's noncustodial or nonadjudicated parent and the child's relatives
5.23 to notify the child's parent and relatives that the child is or will be placed in foster care; and
5.24 provide the child's parent and relatives with a list of legal resources. The notice to the child's
5.25 noncustodial or nonadjudicated parent and relatives must also include the information
5.26 required under section 260C.221, subdivision 2, paragraph (b). The responsible social
5.27 services agency must maintain detailed records of the agency's efforts to notify parents and
5.28 relatives under this section.

5.29 (b) Notwithstanding the provisions of section 260C.219, the responsible social services
5.30 agency must assess an African American or a disproportionately represented child's
5.31 noncustodial or nonadjudicated parent's ability to care for the child before placing the child
5.32 in foster care. If a child's noncustodial or nonadjudicated parent is willing and able to provide

6.1 daily care for the African American or disproportionately represented child temporarily or
6.2 permanently, the court shall order ~~that the child be placed in~~ into the home of the noncustodial
6.3 or nonadjudicated parent pursuant to section 260C.178 or 260C.201, subdivision 1. The
6.4 responsible social services agency must make active efforts to assist a noncustodial or
6.5 nonadjudicated parent with remedying any issues that may prevent the child from being
6.6 ~~placed with the~~ ordered into the home of a noncustodial or nonadjudicated parent.

6.7 (c) The relative search, notice, engagement, and placement consideration requirements
6.8 under section 260C.221 apply under this act.

6.9 Sec. 9. Minnesota Statutes 2024, section 260.66, subdivision 1, is amended to read:

6.10 Subdivision 1. **Emergency removal or placement permitted.** Nothing in this section
6.11 shall be construed to prevent the emergency removal of an African American or a
6.12 disproportionately represented ~~child's parent or custodian~~ child or the emergency placement
6.13 of the child in a foster setting in order to prevent imminent physical damage or harm to the
6.14 child.

6.15 Sec. 10. Minnesota Statutes 2024, section 260.691, subdivision 1, is amended to read:

6.16 Subdivision 1. **Establishment and duties.** (a) The African American Child and Family
6.17 Well-Being Advisory Council is established for the Department of Children, Youth, and
6.18 Families.

6.19 (b) The council shall consist of 31 members appointed by the commissioner and must
6.20 include representatives with lived personal or professional experience within African
6.21 American communities. Members may include but are not limited to youth who have exited
6.22 the child welfare system; parents; legal custodians; relative and kinship caregivers or foster
6.23 care providers; community service providers, advocates, and members; county and private
6.24 social services agency case managers; representatives from faith-based institutions; academic
6.25 professionals; a representative from the Council for Minnesotans of African Heritage; the
6.26 Ombudsperson for African American Families; and other individuals with experience and
6.27 knowledge of African American communities. Council members must be selected through
6.28 an open appointments process under section 15.0597. The terms, compensation, and removal
6.29 of council members are governed by section 15.059.

6.30 (c) ~~The African American Child Well-Being Advisory~~ council must:

7.1 (1) review annual reports related to African American children involved in the child
7.2 welfare system. These reports may include but are not limited to the maltreatment,
7.3 out-of-home placement, and permanency of African American children;

7.4 (2) assist with and make recommendations to the commissioner for developing strategies
7.5 to reduce maltreatment determinations, prevent unnecessary out-of-home placement, promote
7.6 culturally appropriate foster care and shelter or facility placement decisions and settings for
7.7 African American children in need of out-of-home placement, ensure timely achievement
7.8 of permanency, and improve child welfare outcomes for African American children and
7.9 their families;

7.10 (3) review summary reports on targeted case reviews prepared by the commissioner to
7.11 ensure that responsible social services agencies meet the needs of African American children
7.12 and their families. Based on data collected from those reviews, the council shall assist the
7.13 commissioner with developing strategies needed to improve any identified child welfare
7.14 outcomes, including but not limited to maltreatment, out-of-home placement, and permanency
7.15 for African American children;

7.16 (4) ~~assist the Cultural and Ethnic Communities Leadership Council with making~~ make
7.17 recommendations to the commissioner and the legislature for public policy and statutory
7.18 changes that specifically consider the needs of African American children and their families
7.19 involved in the child welfare system;

7.20 (5) advise the commissioner on stakeholder engagement strategies and actions that the
7.21 commissioner and responsible social services agencies may take to improve child welfare
7.22 outcomes for African American children and their families;

7.23 (6) assist the commissioner with developing strategies for public messaging and
7.24 communication related to racial disproportionality and disparities in child welfare outcomes
7.25 for African American children and their families;

7.26 (7) assist the commissioner with identifying and developing internal and external
7.27 partnerships to support adequate access to services and resources for African American
7.28 children and their families, including but not limited to housing assistance, employment
7.29 assistance, food and nutrition support, health care, child care assistance, and educational
7.30 support and training; and

7.31 (8) assist the commissioner with developing strategies to promote the development of
7.32 a culturally diverse and representative child welfare workforce in Minnesota that includes
7.33 professionals who are reflective of the community served and who have been directly
7.34 impacted by lived experiences within the child welfare system. The council must also assist

8.1 the commissioner with exploring strategies and partnerships to address education and training
8.2 needs, hiring, recruitment, retention, and professional advancement practices.

8.3 Sec. 11. Minnesota Statutes 2024, section 260.692, is amended to read:

8.4 **260.692 AFRICAN AMERICAN CHILD AND FAMILY WELL-BEING UNIT.**

8.5 Subdivision 1. **Duties.** The African American Child and Family Well-Being Unit,
8.6 currently established by the commissioner, must:

8.7 (1) assist with the development of African American cultural competency training and
8.8 review child welfare curriculum in the Minnesota Child Welfare Training Academy to
8.9 ensure that responsible social services agency staff and other child welfare professionals
8.10 are appropriately prepared to engage with African American children and their families and
8.11 to support family preservation and reunification;

8.12 (2) provide technical assistance, including on-site technical assistance, and case
8.13 consultation to responsible social services agencies to assist agencies with implementing
8.14 and complying with the Minnesota African American Family Preservation and Child Welfare
8.15 Disproportionality Act;

8.16 (3) monitor individual county and statewide disaggregated and nondisaggregated data
8.17 to identify trends and patterns in child welfare outcomes, including but not limited to
8.18 reporting, maltreatment, out-of-home placement, and permanency of African American
8.19 children and develop strategies to address disproportionality and disparities in the child
8.20 welfare system;

8.21 (4) develop and implement a system for conducting case reviews when the commissioner
8.22 receives reports of noncompliance with the Minnesota African American Family Preservation
8.23 and Child Welfare Disproportionality Act or when requested by the parent or custodian of
8.24 an African American child. Case reviews may include but are not limited to a review of
8.25 placement prevention efforts, safety planning, case planning and service provision by the
8.26 responsible social services agency, relative placement consideration, and permanency
8.27 planning;

8.28 (5) establish and administer a request for proposals process for African American and
8.29 disproportionately represented family preservation grants under section 260.693, monitor
8.30 grant activities, and provide technical assistance to grantees;

8.31 (6) in coordination with the African American Child and Family Well-Being Advisory
8.32 Council, coordinate services and create internal and external partnerships to support adequate
8.33 access to services and resources for African American children and their families, including

9.1 but not limited to housing assistance, employment assistance, food and nutrition support,
9.2 health care, child care assistance, and educational support and training; and

9.3 (7) develop public messaging and communication to inform the public about racial
9.4 disparities in child welfare outcomes, current efforts and strategies to reduce racial disparities,
9.5 and resources available to African American children and their families involved in the
9.6 child welfare system.

9.7 Subd. 2. **Case reviews.** (a) The African American Child and Family Well-Being Unit
9.8 must conduct systemic case reviews to monitor targeted child welfare outcomes, including
9.9 but not limited to maltreatment, out-of-home placement, and permanency of African
9.10 American children.

9.11 (b) The reviews under this subdivision must be conducted using a random sampling of
9.12 representative child welfare cases stratified for certain case related factors, including but
9.13 not limited to case type, maltreatment type, if the case involves out-of-home placement,
9.14 and other demographic variables. In conducting the reviews, unit staff may use court records
9.15 and documents, information from the social services information system, and other available
9.16 case file information to complete the case reviews.

9.17 (c) The frequency of the reviews and the number of cases, child welfare outcomes, and
9.18 selected counties reviewed shall be determined by the unit in consultation with the African
9.19 American Child and Family Well-Being Advisory Council, with consideration given to the
9.20 availability of unit resources needed to conduct the reviews.

9.21 (d) The unit must monitor all case reviews and use the collective case review information
9.22 and data to generate summary case review reports, ensure compliance with the Minnesota
9.23 African American Family Preservation and Child Welfare Disproportionality Act, and
9.24 identify trends or patterns in child welfare outcomes for African American children.

9.25 (e) The unit must review information from members of the public received through the
9.26 compliance and feedback portal, including policy and practice concerns related to individual
9.27 child welfare cases. After assessing a case concern, the unit may determine if further
9.28 necessary action should be taken, which may include coordinating case remediation with
9.29 other relevant child welfare agencies in accordance with data privacy laws, including the
9.30 African American Child and Family Well-Being Advisory Council, and offering case
9.31 consultation and technical assistance to the responsible local social services agency as
9.32 needed or requested by the agency.

9.33 Subd. 3. **Reports.** (a) The African American Child and Family Well-Being Unit must
9.34 provide regular updates on unit activities, including summary reports of case reviews, to

10.1 the African American Child and Family Well-Being Advisory Council, and must publish
10.2 an annual census of African American children in out-of-home placements statewide. The
10.3 annual census must include data on the types of placements, age and sex of the children,
10.4 how long the children have been in out-of-home placements, and other relevant demographic
10.5 information.

10.6 (b) The African American Child and Family Well-Being Unit shall gather summary data
10.7 about the practice and policy inquiries and individual case concerns received through the
10.8 compliance and feedback portal under subdivision 2, paragraph (e). The unit shall provide
10.9 regular reports of the nonidentifying compliance and feedback portal summary data to the
10.10 African American Child and Family Well-Being Advisory Council to identify child welfare
10.11 trends and patterns to assist with developing policy and practice recommendations to support
10.12 eliminating disparity and disproportionality for African American children.

10.13 Sec. 12. Minnesota Statutes 2024, section 260C.001, subdivision 2, is amended to read:

10.14 Subd. 2. **Juvenile protection proceedings.** (a) The paramount consideration in all
10.15 juvenile protection proceedings is the health, safety, and best interests of the child. In
10.16 proceedings involving an American Indian child, as defined in section 260.755, subdivision
10.17 8, the best interests of the child must be determined consistent with sections 260.751 to
10.18 260.835 and the Indian Child Welfare Act, United States Code, title 25, sections 1901 to
10.19 1923.

10.20 (b) The purpose of the laws relating to juvenile protection proceedings is:

10.21 (1) to secure for each child under the jurisdiction of the court, the care and guidance,
10.22 preferably in the child's own home, as will best serve the spiritual, emotional, mental, and
10.23 physical welfare of the child;

10.24 (2) to provide judicial procedures that protect the welfare of the child;

10.25 (3) to preserve and strengthen the child's family ties whenever possible and in the child's
10.26 best interests, removing the child from the custody of parents only when the child's welfare
10.27 or safety cannot be adequately safeguarded without removal;

10.28 (4) to ensure that when removal from the child's own family is necessary and in the
10.29 child's best interests, the responsible social services agency has legal responsibility for the
10.30 child removal either:
