2.15	Subd. 2. Coordinator's duties. The pilot project coordinator is responsible for
2.16	general oversight of the pilot project program. Among the coordinator's duties are

2.18	coordinator must develop, or assist state agencies in developing, any useful application
2.19	forms and procedures for use by applicants and state agencies.

4.8	The coordinator, in consultation with the commissioner of any affected state agency,
