- (a) The provisions of this chapter shall not be deemed to prevent local authorities, with respect to streets and highways under their jurisdiction, and with the consent of the commissioner, with respect to state trunk highways, within the corporate limits of a municipality, or within the limits of a town in a county in this state now having or which may hereafter have, a population of 500,000 or more, and a land area of not more than 600 square miles, and within the reasonable exercise of the police power from:

Subdivision 1. Violation detected by traffic safety camera. Any fine or penalty imposed for operating a motor vehicle in violation of an ordinance or other local law enacted under the authority granted in section 169.06, subdivision 4, and detected through the use of a traffic safety camera shall be consistent with section 609.0332, and shall in no instance exceed a petty misdemeanor.

- Subd. 2. Signage requirement. Any government entity which regulates traffic by means of traffic safety cameras must post signage notifying the drivers that traffic safety cameras are in place within 500 feet of each intersection where traffic safety cameras are in place. Signs need only be placed at those approaches to intersections regulated by a traffic safety camera.
- Subd. 3. **Data.** (a) All data collected through the operation of traffic safety cameras are private data on individuals under section 13.02, with the exception of summary data under section 13.02, subdivision 19.
- (b) All private data on individuals collected through the operation of traffic safety cameras may be retained by a government entity utilizing traffic safety cameras to regulate traffic for a maximum of 30 days after the final adjudication of the underlying alleged violation and all appeals.
- (c) A contract with a private entity to operate traffic safety cameras must comply with section 13.05, subdivision 11.
- (d) A contract with a private entity to operate traffic safety cameras shall state that the private entity may retain private data on individuals collected through the operation of traffic safety cameras for a maximum of 30 days after being notified of the final
