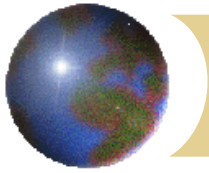

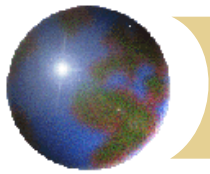

Home and Community Based Waivers

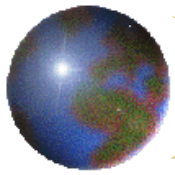
- ❖ Community Alternatives for Disabled Individuals (CADI) – 2423
- ❖ Traumatic Brain Injury Home and Community Based Waiver (TBI) – 153
- ❖ Community Alternative Care (CAC) – 20
- ❖ Developmental Disabilities (DD) – 1712



Establishing Eligibility

Who is eligible for DD Waiver services?

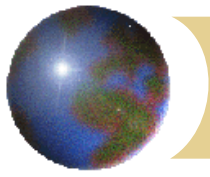
1. MA Eligible based on Disability Diagnosis
2. A diagnosis of mental retardation, or a related condition (as evident by IQ test and Adaptive test)
3. ICF/MR level of care
4. Require daily interventions & services; 24-hour plan of care, a residential habilitation service
5. Choice of Waiver services instead of ICF/MR
6. Needs over and above those available through the MA State Plan



Establishing Eligibility

Who is eligible for CADI Waiver Services?

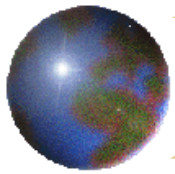
- ⊕ MA recipient or eligible for MA based on income or assets
- ⊕ Disability Certification
- ⊕ Under age 65
- ⊕ Nursing Facility Level of Care
- ⊕ Assessed needs for supports and services exceed those available under other funding sources
- ⊕ Choice of care and services



Establishing Eligibility

Who is eligible for TBI Waivered Services?

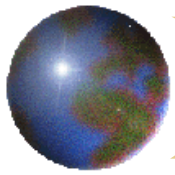
- ⊕ MA recipient or eligible for MA based on income or assets
- ⊕ Disability Certification
- ⊕ Under age 65
- ⊕ Nursing Facility or Neurobehavioral Hospital Level of Care
- ⊕ Documented Diagnosis
- ⊕ Significant Behavioral/Cognitive impairments
- ⊕ Assessment on a Cognitive Functioning Scale



Case Management Responsibilities

Screening & Assessment

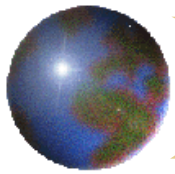
- ✦ Administer Long Term Care Consultation (LTCC) or DD Screening Document
- ✦ Initial Service Planning and Care Plan based on assessed needs
- ✦ Referral to appropriate services



Case Management Responsibilities

Case Management

- ✦ Plan Development and Revision
- ✦ Service Authorization & Monitoring
- ✦ Information & Referral (broker of services)
- ✦ On-going Assessment

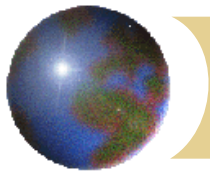

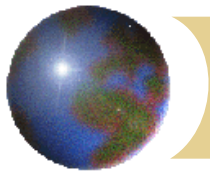

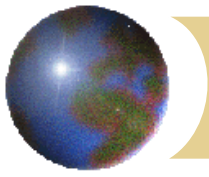
