1.5 Subdivision 1. **When authorized.** (a) Except as otherwise provided in subdivisions 2
1.6 to 4, reasonable force may be used upon or toward the person of another without the other's
1.7 consent when the following circumstances exist or the actor reasonably believes them to
1.8 exist:

1.9 (1) when used by a public officer or one assisting a public officer under the public
1.10 officer's direction:

1.11 (i) in effecting a lawful arrest; or

1.12 (ii) in the execution of legal process; or

1.13 (iii) in enforcing an order of the court; or

1.14 (iv) in executing any other duty imposed upon the public officer by law; or

1.15 (2) when used by a person not a public officer in arresting another in the cases and in
1.16 the manner provided by law and delivering the other to an officer competent to receive the
1.17 other into custody; or

1.18 (3) when used by any person in resisting or aiding another to resist an offense against
1.19 the person; or

1.20 (4) when used by any person in lawful possession of real or personal property, or by
1.21 another assisting the person in lawful possession, in resisting a trespass upon or other
1.22 unlawful interference with such property; or

2.1 (5) when used by any person to prevent the escape, or to retake following the escape,
2.2 of a person lawfully held on a charge or conviction of a crime; or

2.3 (6) when used by a parent, guardian, or other lawful custodian of a child, in the exercise
2.4 of lawful authority, to restrain or correct such child; or

2.5 (7) when used by a teacher, school principal, school employee, school bus driver, or
2.6 other agent of a district in the exercise of lawful authority, to restrain a child or pupil to
2.7 prevent bodily harm or death to the child, pupil, or another; or

2.8 (8) when used by a common carrier in expelling a passenger who refuses to obey a lawful
2.9 requirement for the conduct of passengers and reasonable care is exercised with regard to
2.10 the passenger's personal safety; or

2.11 (9) when used to restrain a person with a mental illness or a person with a developmental
2.12 disability from self-injury or injury to another or when used by one with authority to do so
2.13 to compel compliance with reasonable requirements for the person's control, conduct, or
2.14 treatment; or

2.15 (10) when used by a public or private institution providing custody or treatment against
2.16 one lawfully committed to it to compel compliance with reasonable requirements for the
2.17 control, conduct, or treatment of the committed person.

2.18 (b) An actor may use reasonable force under the circumstances described in paragraph
2.19 (a), clause (3), regardless of whether a reasonable possibility of retreat to avoid the danger
2.20 exists.

2.21 **EFFECTIVE DATE.** This section is effective August 1, 2025, and applies to acts
2.22 committed on or after that date."
