### **Bill Description**

Bill expands the debt issuance authority of Minnesota Higher Education Facilities Authority (MHEFA) to include nonprofit HealthCare and nonprofit Senior Living facility project financing.

The expansion is pursuant to requests from nonprofit HealthCare and nonprofit Senior Living organizations received by MHEFA in recent years. The expansion will also provide a stronger base for the Authority to provide conduit (pass-through) bond issuance services to existing nonprofit Higher Education borrowers in the future.

This bill aligns MHEFA bond issuing authority with similar Agencies in surrounding States and other States in the nation.

#### **Assumptions**

MHEFA requires no State appropriations or funds, has no taxing power, and is fully funded by fees assessed to borrowers who issue through MHEFA.

MHEFA Bonds are NOT OBLIGATIONS OF THE STATE OF MINNESOTA. The State of Minnesota has no financial, legal, or moral obligation to pay debt service on MHEFA issued debt and does not provide any funding for MHEFA operations.

Expanded issuance to include additional sectors will require additional staff to manage additional financings and additional borrowers expected based on prior requests for financing assistance from nonprofit HealthCare and nonprofit Senior Living organizations.

MHEFA fee income is generated from fees charged to borrowers. MHEFA fees are charged based on the cost of

operations and generate no surplus or deficit for MHEFA.

MHEFA is not included in any State Fund and funds all operations of MHEFA through fees charged to borrowers.

MHEFA is not included in the Consolidated State of Minnesota Financial Statement. MHEFA is only referenced in the Notes to the State of Minnesota Financial Statement.

#### Long-Term Fiscal Considerations

MHEFA receives no State support and is financially independent. The purpose of MHEFA is to provide cost effective financing for institutions of nonprofit Higher Education institutions and HF355/SF439 expands the authority of MHEFA to provide cost effective tax-exempt financing for nonprofit HealthCare institutions and nonprofit Senior Living organizations.

There is no long-term fiscal consideration or obligation of the State of Minnesota from this bill.
