1.6	Section 1. Minnesota Statutes 2024, section 169.71, subdivision 4a, is amended to read:
1.7	Subd. 4a. Glazing material; exceptions. (a) Subdivision 4 does not apply to glazing
1.8	materials that:
1.9	(1) have not been modified since the original installation, nor to original replacement
1.10	windows and windshields, that were originally installed or replaced in conformity with
1.11	Federal Motor Vehicle Safety Standard 205;
1.12	(2) are required to satisfy prescription or medical needs, provided:
1.13	(i) the vehicle's driver or a passenger possesses a prescription or a physician's statement
1.14	of medical need;
1.15	(ii) the prescription specifically states whether the medical need is a temporary or
1.16	permanent condition;
1.17	(iii) the prescription or statement specifically states the minimum percentage that light
1.18	transmittance may be reduced to satisfy the prescription or medical needs of the patient;
