Summary

This bill would require Minnesota Management and Budget (MMB) to include the budgetary impacts of fraud committed against state programs in the agency's biannual budget forecasts. Before each forecast, MMB would consult the leaders of legislative budget and tax committees regarding MMB's assumptions and methods for estimating fraud's impact on state revenues and expenditures during the forecast period.
