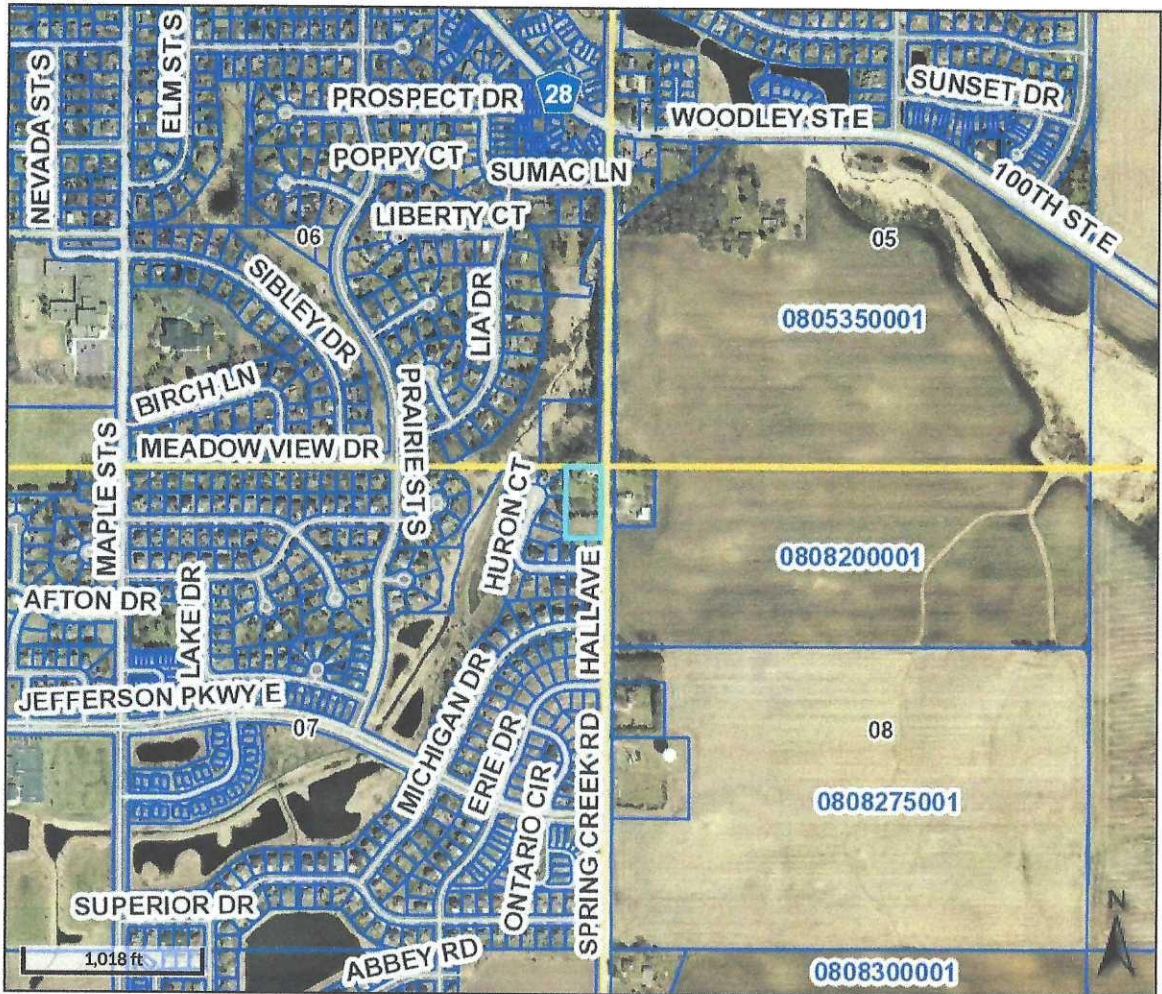

One census block (1 household with only 2 voters) has been redistricted as a stand-alone precinct. Voter privacy/confidentiality rights are violated when election results are reported on a precinct-by-precinct basis. The general public will know who these voters voted for and how they voted on any particular ballot question(s). With recent contention surrounding elections, it is critical for voters to vote with confidence and know their votes are private. A household with two voters making up an entire precinct violates the privacy/confidentiality standards expected when voting. We respectfully request block B1027 be moved to 58B for the 2022 redistricting cycle effective with the August 2022 election and continuing until this home is annexed by the City of Northfield or until the next redistricting cycle, whichever comes first.

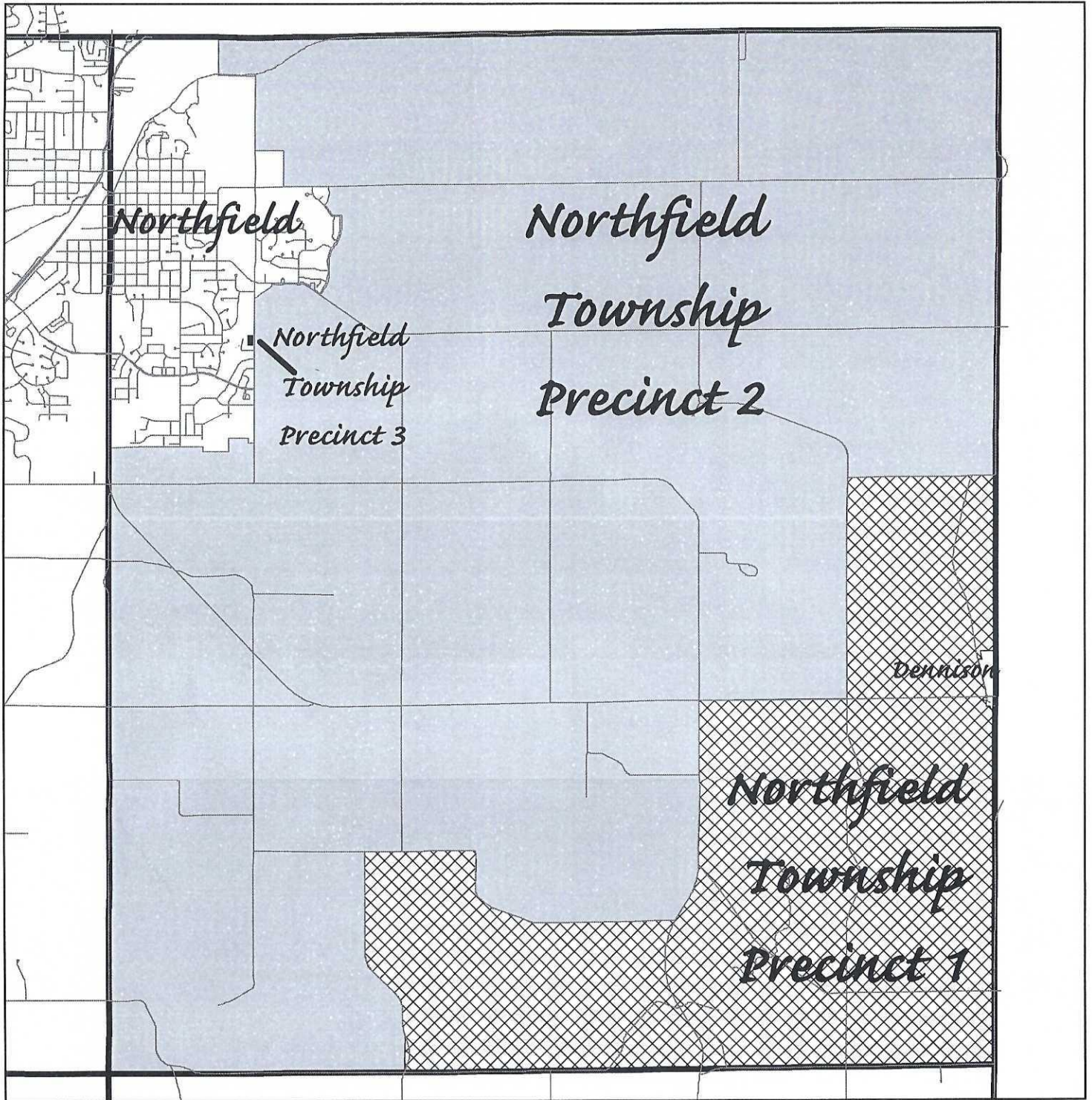

# Northfield Township Precincts 2022

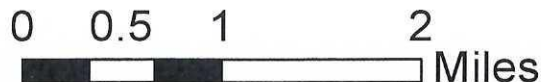
