On behalf of the Start Early Funders Coalition, we would like to share our appreciation the inclusion of the Community Solutions for Healthy Child Development Grant Program in HF 2390 before your committee. Our vision as a Coalition is that every child in Minnesota is physically, socially, emotionally and cognitively prepared for school and lifelong success. Our coalition is committed to supporting policies that will benefit low-income, rural and Black, Indigenous and children of color and their families; and the programs that serve them.

The inclusion of the Community Solutions Fund in HF 2390 provides the opportunity to sustainably fund the Community Solutions Fund for Healthy Child Development Grant Program out of the Minnesota Department of Health into the future. We have seen firsthand the impact Community Solutions Grant Program has had with funded organizational partners on their ability to deeply engage with families, children and early childhood systems to improve the lives of communities of color and rural communities. The Community Solutions Grant Program has supported numerous Family, Friend and Neighbor efforts, supporting a critical element of our early childhood system that lacks deep investment and support. It is critical to support the reach and sustainability of high impact programs like the Community Solutions Grants Program. Communities closest to the problems are also closest to the solutions and are often the furthest from the resources. The Community Solutions Grant Program is a critical policy tool to solve this problem. As supporters of this initiative and funders of the Community Solutions Fund: A New Tool for Equity report that highlights key learnings from the Community Solutions Fund; we know that investment in these programs is necessary. These programs support children and family's immediate and long-term health by improving the community conditions that drive health and educational outcomes.
