4.1 Subd. 16. **Notifications required and noncompliance.** (a) A certification holder must
4.2 notify the commissioner, in a manner prescribed by the commissioner, and obtain the
4.3 commissioner's approval before making any change to the name of the certification holder
4.4 or the location of the mental health clinic.

4.5 (b) Changes in mental health clinic organization, staffing, treatment, or quality assurance
4.6 procedures that affect the ability of the certification holder to comply with the minimum
4.7 standards of section 245I.20 must be reported in writing by the certification holder to the
4.8 commissioner within 15 days of the occurrence. Review of the change must be conducted
4.9 by the commissioner. A certification holder with changes resulting in noncompliance in
4.10 minimum standards must receive written notice and may have up to 180 days to correct the
4.11 areas of noncompliance before being decertified. Interim procedures to resolve the
4.12 noncompliance on a temporary basis must be developed and submitted in writing to the
4.13 commissioner for approval within 30 days of the commissioner's determination of the
4.14 noncompliance. Not reporting an occurrence of a change that results in noncompliance
4.15 within 15 days, failure to develop an approved interim procedure within 30 days of the
4.16 determination of the noncompliance, or nonresolution of the noncompliance within 180
4.17 days will result in immediate decertification.

4.18 (c) The mental health clinic may be required to submit written information to the
4.19 department to document that the mental health clinic has maintained compliance with the
4.20 rule and mental health clinic procedures."

4.33 team member must participate in an ancillary meeting. A mental health professional, certified
4.34 rehabilitation specialist, clinical trainee, or mental health practitioner who participated in

5.1 the most recent weekly team meeting may lead the ancillary meeting. During the ancillary
5.2 meeting, the treatment team member leading the ancillary meeting must review the
5.3 information that was shared at the most recent weekly team meeting, including revisions
5.4 to client treatment plans and other information that the treatment supervisors exchanged
5.5 with treatment team members. The license holder must document all ancillary meetings,
5.6 including the names of meeting attendees."
