1.7 Subd. 3. **Uniform outcome report card; reporting by commissioner.** (a) By December
1.8 31 of each ~~even-numbered~~ year, the commissioner must report to the chairs and ranking
1.9 minority members of the committees of the house of representatives and the senate having
1.10 jurisdiction over economic development and workforce policy and finance the following
1.11 information separately for ~~each of the previous two~~ fiscal or calendar ~~years~~ year, for each
1.12 program subject to the requirements of subdivision 1:

1.13 (1) the total number of participants enrolled;

1.14 (2) the median pre-enrollment wages based on participant wages for the second through
1.15 the fifth calendar quarters immediately preceding the quarter of enrollment excluding those
1.16 with zero income;

1.17 (3) the total number of participants with zero income in the second through fifth calendar
1.18 quarters immediately preceding the quarter of enrollment;

1.19 (4) the total number of participants enrolled in training;

1.20 (5) the total number of participants enrolled in training by occupational group;

1.21 (6) the total number of participants that exited the program and the average enrollment
1.22 duration of participants that have exited the program during the year;

1.23 (7) the total number of exited participants who completed training;

1.24 (8) the total number of exited participants who attained a credential;

1.25 (9) the total number of participants employed during three consecutive quarters
1.26 immediately following the quarter of exit, by industry;

1.27 (10) the median wages of participants employed during three consecutive quarters
1.28 immediately following the quarter of exit;

1.29 (11) the total number of participants employed during eight consecutive quarters
1.30 immediately following the quarter of exit, by industry;

(12) the median wages of participants employed during eight consecutive quarters immediately following the quarter of exit;

(13) the total cost of the program;

(14) the total cost of the program per participant;

(15) the cost per credential received by a participant; and

(16) the administrative cost of the program.

(b) In addition to meeting any reporting requirements included in the grant agreement, each program grant recipient and any individually specified grantee named in an appropriation to be administered by or through the commissioner is subject to this section and must provide the following information to the commissioner:

(1) a summary of the purpose of the grant;

(2) the amount of the grant awarded to the grantee;

(3) the amount of previous grants issued by or through the commissioner of employment and economic development to the grantee for the previous four years;

(4) to the extent that participant geographic data is available, if a grantee uses grant money to provide services to persons who reside outside of Minnesota, the grantee must list the states where non-Minnesotan participants reside and an explanation of why grant money was used to provide services to non-Minnesota residents; and

(5) the organization's charitable giving ratio if available on the grantee's Internal Revenue Service Form 990.

The commissioner must provide the information required in this paragraph for each grantee separately in the report required under paragraph (a). A grantee must provide updated information required to complete the report under paragraph (a) to the commissioner annually by October 1 until October 1 in the year when all of the grant funds have been spent or canceled.

(c) The report to the legislature must contain participant information by education level, race and ethnicity, gender, and geography, and a comparison of exited participants who completed training and those who did not.

~~(e)~~ (d) The requirements of this section apply to programs administered directly by the commissioner or administered by other organizations under a grant made by the department.

3.1 (e) As a condition of receiving a grant from the department, a grantee must agree to
3.2 provide the commissioner any information necessary to complete the report required by
3.3 this section.

3.5 Subd. 6. **Limitations on future appropriations.** (a) A program, program grantee, or
3.6 direct appropriation grant recipient that is a recipient of public funds and subject to the
3.7 requirements of this section as of May 1, 2014 2025, is not eligible for additional state
3.8 appropriations for any fiscal year beginning after June 30, 2015 2026, and the commissioner
3.9 may withhold grant disbursements from a grantee, unless all of the reporting requirements
3.10 under ~~subdivision~~ section 116L.98, subdivisions 3 and 4 have been satisfied.

3.11 (b) A program, program grantee, or direct appropriation grant recipient with an initial
3.12 request for funds on or after July 1, 2014 2025, may be considered for receipt of public
3.13 funds for the first two fiscal years only if a plan that demonstrates how the data collection
3.14 and reporting requirements under ~~subdivision~~ section 116L.98, subdivisions 3 and 4 will
3.15 be met has been submitted and approved by the commissioner. Any subsequent request for
3.16 funds after an initial request is subject to the requirements of paragraph (a)."
