

1.1 ARTICLE 1 - DAILY BUSINESS

1.2 1.01 CONVENING OF THE HOUSE. Unless otherwise ordered, the House convenes at 3:30  
1.3 p.m. The Speaker must take the chair at the appointed hour and call the House to order.

1.4 The call to order is followed by a prayer by the Chaplain or time for a brief meditation, then  
1.5 by the pledge of allegiance to the flag of the United States of America, and then by a call of the  
1.6 roll of members. The names of members present and members excused must be entered in the  
1.7 Journal of the House.

1.8 1.02 READING OF THE JOURNAL. If a quorum is present, the Chief Clerk must read the  
1.9 Journal of the preceding day, unless otherwise ordered. The House may correct errors in the Journal  
1.10 of the preceding day.

1.11 1.03 ORDER OF BUSINESS. After the Journal is read, the order of business of the day is:

1.12 (1) Presentation of petitions or other communications

1.13 (2) Reports of standing committees and divisions

1.14 (3) Second reading of House bills

1.15 (4) Second reading of Senate bills

1.16 (5) Reports of select committees

1.17 (6) Introduction and first reading of House bills

1.18 (7) Consideration of messages from the Senate

1.19 (8) First reading of Senate bills

1.20 (9) Calendar for the day

1.21 (10) Motions and resolutions

1.22 The House may advance or revert from any order of business to any other order of business  
1.23 either without objection, or by majority vote of the whole House.

2.1 Conference committees on House bills and the Committee on Rules and Legislative  
2.2 Administration may report at any time.

2.3 1.04 REPORTING OF BILLS. A bill must be reported to the House on three different days  
2.4 before its passage, except as provided in Rule 5.02. The first report, called the first reading, occurs  
2.5 when it is introduced; the second report, called the second reading, occurs when it has been reported  
2.6 by the appropriate standing committees and divisions for consideration by the House; the third  
2.7 report, called the third reading, occurs when it is ready for the vote on passage.

2.8 1.10 INTRODUCTION OF BILLS AND RESOLUTIONS. A bill or resolution must be  
2.9 submitted to the Speaker at least 24 hours before the convening of the daily session at which it is  
2.10 to be introduced.

2.11 A bill or resolution must be introduced in duplicate and each copy must bear the signature of  
2.12 the member or the name of the committee or division introducing it.

2.13 In regular session, a bill prepared by a department or agency of state government must be  
2.14 introduced and given its first reading at least ten days before the date of the first committee deadline.

2.15 Each annual session, the Committee on Rules and Legislative Administration may designate a  
2.16 date after which a House File may not be introduced during that annual session, unless approved  
2.17 for introduction by the Committee on Rules and Legislative Administration. The date must be at  
2.18 least 14 calendar days after the Committee acts under this paragraph, but no earlier than May 1 of  
2.19 each annual session.

2.20 1.11 FIRST READING AND REFERENCE OF BILLS. A bill or resolution must be reported  
2.21 and given its first reading when it is introduced. A bill or resolution must not be objected to when  
2.22 it is introduced.

2.23 After its first reading, the Speaker must refer a bill or resolution to the appropriate standing  
2.24 committee or division, except as provided in Rule 1.15 and Rule 1.13.

2.25 Congratulatory resolutions referred to in Rule 4.02 are exempt from this Rule.

2.26 Except as otherwise provided in these Rules, after the Speaker refers a bill or resolution, a  
2.27 majority vote of the whole House is required for the House to re-refer the bill or resolution.

2.28 1.12 AUTHORS OF BILLS AND RESOLUTIONS. A bill, memorial, or resolution must not  
2.29 have more than 35 authors. After a bill or resolution is introduced and given its first reading: (a) a  
2.30 member may be removed as an author, by motion of the member; and (b) a member wishing to be  
2.31 an author may be added as an author, by motion of the author of the bill or resolution.

2.32 1.13 INTRODUCTION OF COMMITTEE OR DIVISION BILLS. A standing or special  
2.33 committee of the House or a division of the House may introduce a bill as a committee or division  
2.34 bill on any subject within its purview. When a committee or division bill is introduced and read for  
2.35 the first time, the Speaker may refer it to a standing committee or division. If the Speaker does not  
2.36 refer it, the bill must be laid over one day. Then it must be read for the second time and placed on  
2.37 the General Register.

3.1 1.14 RECESS BILL INTRODUCTIONS. During the period between the last day of the regular  
3.2 session in an odd-numbered year and the first day of the regular session in the next year, a bill filed  
3.3 with the Speaker for introduction must be given a file number and may be unofficially referred by  
3.4 the Speaker to an appropriate standing committee or division.

3.5 1.15 DISPOSITION OF SENATE FILES. (a) A Senate File received by the House that is  
3.6 accompanied by a message announcing its passage by the Senate must be referred to the appropriate  
3.7 standing committee or division under Rule 1.11. But if a Senate File is received that a member  
3.8 requests be compared to a House File already reported by a standing committee or division of the  
3.9 House and placed on the General Register or on the Calendar for the Day, the Senate File must be  
3.10 referred to the Chief Clerk for comparison. The Chief Clerk shall report whether the Senate File is  
3.11 identical or not identical to the House File and the Senate File may, by majority vote, be substituted  
3.12 for the House File and take its place. The fact that the bills are identical or not identical must be  
3.13 entered in the Journal and the House File is then considered withdrawn.

3.14 (b) A Senate File that is amended on the floor of the House, except at the time of final passage,  
3.15 and a Senate File that has been reported to the House with amendments by a House standing  
3.16 committee or division, must be unofficially engrossed and reprinted by the Chief Clerk. An  
3.17 amendment may be offered to an unofficial engrossment of a Senate File.

3.18 (c) Except after the last Thursday on which the Legislature can meet in regular session in odd-  
3.19 or even-numbered years, or after a date determined by the Committee on Rules and Legislative  
3.20 Administration, a motion that the House concur in Senate amendments to a House File is not in  
3.21 order until 12 hours after the Speaker announces that a message from the Senate has been received  
3.22 requesting concurrence by the House to amendments adopted by the Senate to a House File.

3.23 1.20 GENERAL REGISTER. The General Register consists of all bills that have received a  
3.24 second reading. Bills must be placed on the General Register in the order that they receive their  
3.25 second reading. A bill must be on the General Register, be given to each member, and be available  
3.26 to the public before it may be considered by the House on the Calendar for the Day or the Fiscal  
3.27 Calendar. Each day that the House meets in session, the Chief Clerk must publish a list of the bills  
3.28 on the General Register.

3.29 1.21 CALENDAR FOR THE DAY. The Calendar for the Day is a list of bills that are to be  
3.30 considered that day by the House. The House must consider each item on the Calendar for the Day  
3.31 in the order determined by the presiding officer. After consideration by the House, unless otherwise  
3.32 disposed of, the bill must immediately be given its third reading and placed upon its passage.

3.33 A bill that has received its second reading may be placed on the Calendar for the Day by the  
3.34 Committee on Rules and Legislative Administration or by order of the House upon the motion of  
3.35 a member as provided in this Rule.

3.36 The Committee on Rules and Legislative Administration must designate the bills that are to be  
3.37 on the Calendar for the Day. During regular session, the Committee must designate the bills by  
3.38 5:00 p.m. the day before the day that the bills are to be on the Calendar, except that the Committee

4.1 may designate the bills at any time after a day specified by the Committee on Rules and Legislative  
4.2 Administration. After the Committee designates the bills, the Chief Clerk must publish the Calendar  
4.3 for the Day. In order to trigger a prefiling requirement, the calendar for the day must be established  
4.4 in accordance with Rule 3.33.

4.5 A bill that is on the General Register for more than ten legislative days may be placed on the  
4.6 Calendar for the Day by a majority vote of the whole House, acting on the motion of a member. A  
4.7 bill placed on the Calendar for the Day in this manner must be considered first the next time that  
4.8 the House reaches the order of business "Calendar for the Day." A member must give notice to the  
4.9 Speaker and the Chief Clerk three legislative days before making a motion to place a bill on the  
4.10 Calendar for the Day. The notice must specify the number and title of the bill. Only the member  
4.11 who gave notice to the Speaker and the Chief Clerk, or another member designated in writing by  
4.12 the member who gave notice, may make the motion to place the bill on the Calendar for the Day.  
4.13 After the third legislative day following the day of notice, the motion must be made the first time  
4.14 that the House reaches the order of business "Motions and Resolutions." If the motion is not made  
4.15 at that time, the member who gave notice forfeits the right to make that motion.

4.16 A bill may be continued on the Calendar for the Day by a majority vote of the whole House. A  
4.17 third motion by the author of a bill to continue it on the Calendar for the Day is not in order; upon  
4.18 such a motion, the bill must be stricken from the Calendar and returned to the General Register in  
4.19 the order of its second reading. The Calendar for the Day expires when the House adjourns for the  
4.20 day, unless the House, by a majority vote of the whole House, continues items remaining on the  
4.21 Calendar to the next day.

4.22 1.22 FISCAL CALENDAR. A finance bill that has had its second reading must be considered  
4.23 by the House when requested by the Chair of the Committee on Ways and Means or by a designee  
4.24 of the Chair. A bill relating to taxes or raising revenue that has had its second reading must be  
4.25 considered by the House when requested by the Chair of the Committee on Taxes or a designee of  
4.26 the Chair.

4.27 During regular session, a chair must announce the intention to make the request by 5:00 p.m.  
4.28 the legislative day before the day that the request for consideration is to be made, except that the  
4.29 Chair may designate the bills at any time after a day specified by the Committee on Rules and  
4.30 Legislative Administration. During periods when the 5:00 p.m. requirement does not apply, the  
4.31 chair must announce the intention at least two hours before making the request. In order to trigger  
4.32 a prefiling requirement a notice given under Rule 1.22 must comply with Rule 3.33.

4.33 After consideration by the House on the Fiscal Calendar, unless otherwise disposed of, the bill  
4.34 must immediately be given its third reading and placed upon its passage.

4.35 1.30 THIRD READING OF BILLS. An amendment must not be received after the third  
4.36 reading of a bill without unanimous consent, except to fill blanks or to amend the title.

4.37 At any time before it is passed, a bill or resolution may be referred or re-referred by a majority  
4.38 vote of the whole House. If the committee or division to which it is referred or re-referred reports

5.1 an amendment to it, the bill or resolution must again be given its second reading and placed on the  
5.2 General Register.

5.3 1.40 PUBLICATION OF BILLS FOR THE HOUSE. After a bill receives its second reading,  
5.4 the bill must be prepared and published or made electronically available for consideration by the  
5.5 House. A majority of the House may order the publication of a bill at any time.

5.6 1.50 ADJOURNING OF THE HOUSE. The House may not meet during a legislative day  
5.7 after midnight, except that the House, by majority vote, may meet past the time of adjournment  
5.8 required by this Rule.

## 5.9 ARTICLE 2 - FLOOR PROCEEDINGS, VOTING, DECORUM

5.10 2.01 ABSENCE OF MEMBERS AND OFFICERS. Unless illness or other sufficient cause  
5.11 prevents attendance, a member or officer of the House must not be absent from a session of the  
5.12 House without the prior permission of the Speaker.

5.13 2.02 CALL OF THE HOUSE. Ten members may demand a call of the House at any time  
5.14 until voting begins. After the House is placed under call, a second roll call on any aspect of a call  
5.15 of the House is out of order.

5.16 When a call is demanded, the doors of the chamber must be closed, the roll called, and the  
5.17 absent members sent for; and no member is allowed to leave the chamber until the roll call is  
5.18 suspended or completed. During the roll call, no motion is in order except a motion pertaining to  
5.19 matters incidental to the call.

5.20 Proceedings under the roll call may be suspended by a majority vote of the whole House. The  
5.21 Sergeant at Arms must not permit a member to leave the Chamber unless the member is excused  
5.22 by the Speaker, or the call of the House has been lifted by a majority vote of the whole House.

5.23 2.03 ROLL CALL VOTE. A roll call vote is required to pass a bill or to adopt a resolution  
5.24 or motion directing the payment of money. In all other cases a roll call vote may be ordered only  
5.25 if 15 members demand it. When the House is taking a roll call vote on another issue, a roll call vote  
5.26 may not be ordered on a motion that members not voting be excused from voting.

5.27 2.04 EXPLAINING OR CHANGING VOTE. A member must not explain a vote or discuss  
5.28 the question during a roll call vote. A member must not change a vote or move for the record an  
5.29 intention to have voted or voted differently after the result of the roll call vote is announced from  
5.30 the chair by the Speaker.

5.31 2.05 EVERY UNEXCUSED MEMBER TO VOTE. A member who has an immediate interest  
5.32 in a question must not vote on it.

5.33 Every other member present before the result of a vote is declared by the presiding officer must  
5.34 vote for or against the matter before the House, unless the House excuses the member from voting.  
5.35 But a member is not required to vote on any matter concerning a memorial resolution.

5.36 A member who does not vote when the member's name is called must state reasons for not  
5.37 voting. After the vote has been taken but before the presiding officer has announced the result of

6.1 the vote, the presiding officer must submit to the House the question: "Shall the member, for the  
6.2 reasons stated, be excused from voting?" The question must be decided without debate. After the  
6.3 question is decided, the presiding officer must announce the result of the vote, after which other  
6.4 proceedings about the nonvoting member may take place.

6.5 2.10 ELECTRONIC VOTING SYSTEM. An electronic voting system under the control of  
6.6 the Speaker may be used to take any vote except a vote on an election or if the House is currently  
6.7 taking a roll call. A member must not vote on a question except at the member's own seat in the  
6.8 chamber.

6.9 2.15 RECORDED FLOOR PROCEEDINGS. Proceedings on the floor of the House must be  
6.10 recorded on an appropriate audio recording medium under the direction of the Chief Clerk. The  
6.11 Chief Clerk must transmit a copy of the recordings to the Director of the Legislative Reference  
6.12 Library. The Legislative Reference Library must keep the recordings available for public use under  
6.13 its rules during the legislative biennium when the recordings were created and for eight years  
6.14 thereafter. The Library may then preserve or dispose of the recordings as the Library sees fit.

6.15 A person may obtain a copy of a recording while it is kept in the Library by paying a fee  
6.16 determined by the House Controller to cover the cost of preparing the copy.

6.17 Discussion preserved under this Rule is not intended to be admissible in a court or administrative  
6.18 proceeding on an issue of legislative intent.

6.19 2.20 DUTIES OF MEMBERS. Members must keep their seats until the Speaker announces  
6.20 adjournment.

6.21 A member, before speaking, must rise and respectfully address the Speaker and must not speak  
6.22 further until recognized by the Speaker. If more than one member rises at the same time, the Speaker  
6.23 must select the member to speak first.

6.24 2.21 NOTICE OF INTENT TO DEBATE A RESOLUTION. A member may give notice of  
6.25 intent to debate a resolution, except a resolution introduced as a house file or a senate file under  
6.26 Rule 4.02 or a resolution offered by the Committee on Rules and Legislative Administration or the  
6.27 Committee on Ethics.

6.28 The notice may be given at any time before the vote is taken on the resolution. If the notice is  
6.29 given, the resolution must be laid over one day without debate or any other action.

6.30 2.30 QUESTIONS OF ORDER. If a member violates the Rules in any way, the Speaker must,  
6.31 or another member may, call the member to order. The member called to order must immediately  
6.32 sit down unless another member moves to permit the member who was called to order to explain.  
6.33 In either case, the House, if appealed to, must decide the question without debate. Only if the  
6.34 decision is in favor of the member called to order may that member proceed. The House may censure  
6.35 or punish a member called to order.

6.36 2.31 OFFENSIVE WORDS IN DEBATE. If a member is called to order for offensive words  
6.37 in debate, the member calling for order must report the words to which exception is taken and the

7.1 Clerk must record them. A member must not be held to answer, or be subject to censure of the  
7.2 House, for language used in debate unless exception is taken before another member speaks or  
7.3 other business takes place.

7.4 2.32 ORDER IN DEBATE. Except for the member who offered the motion, amendment, or  
7.5 proposition under consideration, a member must not speak more than twice on the subject, without  
7.6 leave of the House, nor more than once until every other member wishing to speak on the subject  
7.7 has had an opportunity to do so.

7.8 2.33 ORDER DURING SESSION. A member must not walk out of or across the Chamber  
7.9 while the Speaker is putting the question. A member must not engage in private conversation while  
7.10 another member is speaking or pass between a speaking member and the Chair. A member must  
7.11 not disrupt order and decorum in the Chamber by possessing or using any audiovisual display,  
7.12 including but not limited to placards, signs, photographs, visual aids, or the use of any video images  
7.13 or audio, except for such items that are distributed to members at their desks for the purpose of  
7.14 conducting business of the day.

7.15 2.34 PERSONS BY THE CHIEF CLERK'S DESK DURING VOTE. No person may remain  
7.16 by the Chief Clerk's desk during a roll call vote.

7.17 2.39 EXECUTIVE BRANCH OR LOBBYIST PRESENCE IN COMMITTEE. No House  
7.18 committee, division or subcommittee shall permit any member or staff of the executive branch,  
7.19 registered lobbyist, or lobbyist principal, to be seated at the committee table with members of the  
7.20 House during official proceedings of committees of the House.

7.21 2.40 ADMITTANCE TO FLOOR. No person other than a member may be admitted to the  
7.22 House Chamber, except: properly authorized employees; the Chief Executive and ex-governors of  
7.23 the State of Minnesota; members of the Senate; heads of departments of the state government;  
7.24 judges of the Supreme Court, Court of Appeals, and District Courts; members of Congress; those  
7.25 persons invited to address the body or a joint convention of the house and senate, and guests for  
7.26 such an address or joint convention; a family member of a member; and properly accredited  
7.27 representatives of radio and television stations, newspapers and press associations, as provided for  
7.28 in these Rules.

7.29 Any other person may be issued a permit by the Speaker good for the day, but that person must  
7.30 be seated near the Speaker's rostrum, and must not engage in conversation that disturbs the business  
7.31 of the House. Before issuing a permit, the Speaker must make certain that the person does not seek  
7.32 the floor of the House to influence decisions of the House.

7.33 The alcoves in the Chambers are for the use of members only, and the Sergeant at Arms must  
7.34 keep them clear of others.

7.35 From one hour before the time the House is scheduled to convene until one hour after the House  
7.36 adjourns for the day, the retiring room is reserved for the exclusive use of the members and  
7.37 employees of the House. As long as the Senate prohibits entry of House members into its retiring  
7.38 room, no Senators may enter the House retiring room during the time it is reserved for exclusive

8.1 use of members and employees. A committee or division meeting must not be held there except  
8.2 emergency meetings authorized by the Speaker. The Sergeant at Arms must strictly enforce this  
8.3 provision.

8.4 Unless an extraordinary condition exists the Speaker must not entertain a request to suspend  
8.5 this Rule or present the request of a member for unanimous consent to suspend this Rule.

8.6 2.41 MEDIA NEWS REPORTERS. Accredited representatives of the press, press associations,  
8.7 and radio and television stations must be given equal press privileges by the House. A person  
8.8 wishing to report proceedings of the House may apply to the Chief Sergeant at Arms for a media  
8.9 pass and assignment to suitable available space. The Sergeant may coordinate the issuance of media  
8.10 passes with the appropriate senate authority.

8.11 Television stations must be permitted to televise sessions of the House. Media representatives  
8.12 must be allowed access to both wells in the gallery of the House chambers.

8.13 2.42 LOBBYISTS. (a) A lobbyist as defined under Minnesota Statutes, section 10A.01,  
8.14 subdivision 21, shall not appear before a House committee pursuant to the lobbyist's employment  
8.15 unless the lobbyist is in compliance with the law requiring lobbyist registration, Minnesota Statutes,  
8.16 sections 10A.03 to 10A.06. A lobbyist, when appearing before a committee, shall disclose to the  
8.17 committee on whose behalf the lobbyist speaks and the purpose of the lobbyist's appearance.

8.18 (b) A lobbyist shall not knowingly, either directly or through a third party, furnish false or  
8.19 misleading information or make a false or misleading statement that is relevant and material to a  
8.20 matter before the House or any of its committees, subcommittees, or divisions when the lobbyist  
8.21 knows or should know it will influence the judgment or action of the House or any of its committees,  
8.22 subcommittees, or divisions.

8.23 (c) The Committee on Ethics shall investigate a complaint by a member of the House in writing  
8.24 under oath received before adjournment sine die in the last year of a House term or during a special  
8.25 session held after that time that a lobbyist has violated Rule 2.42. The investigatory procedures of  
8.26 Rule 6.10 apply, except as provided in this rule. The complaint and proceedings on the complaint  
8.27 are private until the Committee has found probable cause to believe that a violation of Rule 2.42  
8.28 has occurred, unless they are made public by the lobbyist whose conduct is the subject of the  
8.29 complaint or by the vote of at least three members of the Committee.

### 8.30 ARTICLE 3 - MOTIONS, AMENDMENTS, AND OTHER PROPOSITIONS

8.31 3.01 AMENDMENTS AND OTHER MOTIONS. An amendment or other motion must not  
8.32 be debated until after it is stated by the Speaker.

8.33 After an amendment or other motion is stated by the Speaker it is in possession of the House,  
8.34 but the mover may withdraw it at any time before it is amended or decided. Unless a motion,  
8.35 resolution, or amendment is withdrawn on the day it is made, it must be entered in the Journal, with  
8.36 the name of the member offering it.



9.1 Except as otherwise permitted by the Speaker, an amendment or other motion must be in writing,  
9.2 and five copies of it must be given to the Chief Clerk.

9.3 3.02 ORDER OF PUTTING QUESTION; FILLING BLANKS. Except for a privileged question,  
9.4 questions before the House or a committee or division must be put in the order they are moved. In  
9.5 filling a blank, a motion for the largest sum or the longest time must be put first.

9.6 3.03 DIVISION OF A QUESTION. A member may request the division of a question that  
9.7 contains more than one separate and distinct point. A motion to strike and insert is not divisible.  
9.8 The failure of a motion to strike does not preclude another motion to amend or to strike and insert.

9.9 3.10 PRECEDENCE OF MOTIONS. While a question is under consideration, only the  
9.10 following motions may be received:

9.11 (1) To fix the time of adjournment

9.12 (2) To adjourn

9.13 (3) To lay on the table

9.14 (4) For the previous question

9.15 (5) To refer

9.16 (6) To postpone to a day certain

9.17 (7) To amend

9.18 (8) To postpone indefinitely

9.19 (9) To pass

9.20 The first four motions must be decided without debate.

9.21 The motions have precedence in the order listed, except that if the motion for the previous  
9.22 question has been properly made, and properly supported, and the main question ordered, the motion  
9.23 to lay on the table is not in order.

9.24 3.11 MOTION TO ADJOURN. A motion to adjourn is always in order except during a roll  
9.25 call.

9.26 After a motion to adjourn is made, before putting the question, the Speaker may permit any  
9.27 member to state reasons why adjournment might be improper at that time. A statement is not  
9.28 debatable and must be limited to two minutes.

9.29 3.12 MOTION TO LAY ON THE TABLE. A motion to lay on the table is not in order on a  
9.30 motion to amend, except that a motion to amend the Rules may be tabled.

9.31 3.13 THE PREVIOUS QUESTION. The previous question may be moved by a member who  
9.32 is supported by 15 members.

9.33 If the motion for the previous question is ordered by a majority of members present, its effect  
9.34 is to put an end to all debate and bring the House to direct vote upon the question.

10.1 Before the presiding officer submits a motion for the previous question to the House, a call of  
10.2 the House is in order. After a majority has ordered the previous question, a call of the House is not  
10.3 in order before the decision on the main question.

10.4 When the previous question is decided in the negative, the main question remains under debate  
10.5 until it is disposed of by a vote on the question, by a subsequent motion calling for the previous  
10.6 question under this Rule, or in some other manner.

10.7 All incidental questions of order arising after a motion is made for the previous question and  
10.8 before the vote on the main question must be decided without debate.

10.9 3.14 MOTION TO RECONSIDER. After a question is decided either in the affirmative or  
10.10 negative, a member who voted with the prevailing side may move to reconsider it. The motion must  
10.11 be made on the same day the vote was taken or on either of the next two days that the House meets  
10.12 in session and has possession of the matter. The motion may be made at any time in the Order of  
10.13 Business. It takes precedence over any other question except a motion to adjourn. The motion to  
10.14 reconsider must not be made if the document, bill, resolution, message, report or other subject of  
10.15 official action on which the vote was taken has left the possession of the House.

10.16 If a motion to reconsider fails, it must not be renewed.

10.17 3.15 MOTION TO RESCIND. A motion to rescind is not in order at any time in any proceeding  
10.18 in the House or in any committee or division of the House.

10.19 3.20 AMENDMENTS TO AMENDMENTS. An amendment may be amended, but an  
10.20 amendment to an amendment must not be amended.

10.21 3.21 MOTIONS AND PROPOSITIONS MUST BE GERMANE. (a) A motion or proposition  
10.22 on a subject different from that under consideration must not be admitted under guise of its being  
10.23 an amendment. A motion, amendment, or other proposition offered to the House is out of order if  
10.24 it is not germane to the matter under consideration. Whether a proposition is germane to the matter  
10.25 under consideration is a question to be decided by the presiding officer, who may put the question  
10.26 to the House.

10.27 (b) An amendment to an amendment on the House floor must relate only to the primary  
10.28 amendment, without introducing any new subject.

10.29 3.22 AMENDMENT TO INCREASE AN APPROPRIATION OR TAX. (a) The concurrence  
10.30 of a majority of the whole House, determined by a roll call vote, is required to adopt an amendment  
10.31 increasing an appropriation or a tax.

10.32 (b) An amendment to an amendment may not increase a tax or a fee, unless the underlying  
10.33 amendment increases the tax or fee in question.

10.34 3.23 CONSTITUTIONAL AMENDMENTS. A constitutional amendment may not be offered  
10.35 as an amendment to a bill on the floor.

10.36 3.30 EXPENDITURE OF HOUSE FUNDS. The concurrence of a majority of the whole  
10.37 House, determined by a roll call vote, is required for favorable action on a resolution or motion

11.1 involving the expenditure of money appropriated by the Legislature to the House. The resolution  
11.2 or motion must be referred to the Committee on Rules and Legislative Administration before being  
11.3 acted on by the House.

11.4 3.33 AMENDMENTS MUST BE PREFILED. (a) An amendment on a bill being considered  
11.5 on the Calendar for the Day or the Fiscal Calendar is out of order unless the amendment has been  
11.6 filed with the Chief Clerk by 12:00 noon on the calendar day prior to the calendar day the bill next  
11.7 can be considered on the Calendar for the Day or the Fiscal Calendar. If a bill next can be considered  
11.8 by the House on the Calendar for the Day or the Fiscal Calendar on a Monday, an amendment must  
11.9 be filed by 12:00 noon on the prior Friday. An amendment is not out of order under this Rule if it  
11.10 is a technical or revisor's change to a bill or an amendment. Whether an amendment is a technical  
11.11 or revisor's change is a question to be decided by the presiding officer, who may put the question  
11.12 to the House.

11.13 (b) Paragraph (a) applies to an amendment to a bill only if by 12:00 noon on the day before the  
11.14 deadline for filing amendments the following has occurred:

11.15 (1) the Committee on Rules and Legislative Administration has designated the bill for inclusion  
11.16 on the Calendar for the Day or a chair has announced intention to place the bill on the Fiscal  
11.17 Calendar; and

11.18 (2) the version of the bill that will be considered on the Calendar for the Day or the Fiscal  
11.19 Calendar is available to members.

11.20 (c) Substitution of language in the House version of a bill for language in the Senate companion  
11.21 bill is not an amendment for purposes of this Rule if notice of the chief author's intent to substitute  
11.22 the House language is given when a bill is placed on the Calendar for the Day or when a chair  
11.23 announces intention to place the bill on the Fiscal Calendar.

11.24 (d) When an amendment is filed with the Chief Clerk, the Chief Clerk must have the amendment  
11.25 posted on the House Web site as soon as is practical. The Speaker may specify procedures for filing  
11.26 amendments under this Rule.

11.27 (e) An amendment to a prefiled amendment on a bill is out of order unless the amendment to  
11.28 the amendment has been filed with the Chief Clerk six hours after the prefiling deadline under  
11.29 paragraph (a). An amendment to a prefiled amendment is not out of order under this Rule if it is a  
11.30 technical or conforming change to a prefiled amendment. Whether an amendment is a technical or  
11.31 conforming change to a prefiled amendment is a question to be decided by the presiding officer,  
11.32 who may put the question to the House.

11.33 (f) An amendment to a bill or a prefiled amendment must include a stamp indicating the date  
11.34 and time that the amendment was drafted.

11.35 (g) This Rule may be waived or the deadlines in this Rule may be extended for an individual  
11.36 bill, or waived for all bills after a certain date, by the Committee on Rules and Legislative  
11.37 Administration.

12.1 (h) If the Calendar for the Day or the Fiscal Calendar is continued, the prefiling period must be  
 12.2 reopened in accordance with paragraphs (a) to (e) of this rule, unless the prefiling period is waived  
 12.3 or extended under paragraph (g) of this rule.

12.4 (i) This prefiling requirement applies when the Committee on Rules and Legislative  
 12.5 Administration announces a date in advance, for adoption of the permanent House or Joint Rules.

12.6 Paragraph (i) applies to an amendment to House or Joint Rules, or an amendment to an  
 12.7 amendment, only if by 12:00 noon on the day before the deadline for filing such amendments the  
 12.8 following has occurred:

12.9 (1) the Committee on Rules and Legislative Administration has designated the House or Joint  
 12.10 Rules for debate on the House Floor; and

12.11 (2) the version of the House or Joint Rules that will be considered on the House Floor is available  
 12.12 to members.

#### 12.13 ARTICLE 4 - BILLS AND RESOLUTIONS

12.14 4.01 BILL AND RESOLUTION FORM. A bill or resolution must not be introduced until it  
 12.15 has been examined and approved by the Revisor of Statutes as to form and compliance with these  
 12.16 Rules and the Joint Rules of the House and Senate. The Revisor's approval must be endorsed on  
 12.17 the bill or resolution.

12.18 A bill that is divided into articles may include or be accompanied by a table of contents.

12.19 4.02 RESOLUTIONS. A statement of facts being forwarded for action to a governmental  
 12.20 official, agency, or body or other similar proposal is a memorial and must be introduced in the same  
 12.21 form and take the same course as a bill. A joint resolution and any resolution requiring the signature  
 12.22 of the governor must be introduced in the same form and take the same course as a bill.

12.23 A resolution must not authorize expenditure from any source other than the money appropriated  
 12.24 by the Legislature to the House.

12.25 Congratulatory resolutions do not require consideration or adoption by the House.

12.26 A resolution must not be changed to a bill, and a bill must not be changed to a resolution.

12.27 4.03 WAYS AND MEANS COMMITTEE; BUDGET RESOLUTION; EFFECT ON  
 12.28 EXPENDITURE AND REVENUE BILLS. (a) The Committee on Ways and Means must hold  
 12.29 hearings as necessary to determine state expenditures and revenues for the fiscal biennium.

12.30 (b) Within 25 days after the last state general fund revenue and expenditure forecast for the  
 12.31 next fiscal biennium becomes available during the regular session in the odd-numbered year, the  
 12.32 Committee on Ways and Means must adopt a budget resolution. The budget resolution: (1) must  
 12.33 set the maximum limit on net expenditures for the next fiscal biennium for the general fund, (2)  
 12.34 must set an amount or amounts to be set aside as a budget reserve and a cash flow account, (3) must  
 12.35 set net spending limits for each budget category represented by the major finance and revenue bills  
 12.36 identified in paragraph (e), and (4) may set limits for expenditures from funds other than the general  
 12.37 fund. The budget resolution must not specify, limit, or prescribe revenues or expenditures by any

13.1 category other than those specified in clauses (1), (2), (3), and (4). After the Committee adopts the  
 13.2 budget resolution, the limits in the resolution are effective during the regular session in the year in  
 13.3 which the resolution is adopted, unless a different or amended resolution is adopted.

13.4 (c) During the regular session in the even-numbered year, before the Committee on Ways and  
 13.5 Means reports a bill containing net increases or decreases in expenditures as compared to general  
 13.6 fund expenditures in the current fiscal biennium estimated by the most recent state budget forecast,  
 13.7 the Committee may adopt a budget resolution. If adopted, the resolution must account for the net  
 13.8 changes in expenditures. The resolution may also (1) set limits for changes in net expenditures for  
 13.9 each budget category represented by the major finance and revenue bills identified in paragraph  
 13.10 (e), and (2) set limits for expenditures from funds other than the general fund.

13.11 If the Committee adopts a budget resolution, it is effective during the regular session that year,  
 13.12 unless a different or amended resolution is adopted.

13.13 (d) The major finance or revenue bills may be combined or separated by a majority vote of  
 13.14 either the Committee on Ways and Means or the Committee on Rules and Legislative Administration.  
 13.15 Combined or separated bills must conform to the limits in the resolution as those limits apply to  
 13.16 the accounts in those bills.

13.17 ~~(e) Major finance and revenue bills are:~~

13.18 ~~the agriculture and food finance bill;~~

13.19 ~~the capital investment finance bill;~~

13.20 ~~the education finance bill;~~

13.21 ~~the energy and climate finance bill;~~

13.22 ~~the environment and natural resources bill;~~

13.23 ~~the greater Minnesota jobs and economic development finance bill;~~

13.24 ~~the health and human services finance bill;~~

13.25 ~~the higher education finance bill;~~

13.26 ~~the housing finance bill;~~

13.35 (e) Major finance and revenue bills are:

- 14.1 the agriculture finance bill;
- 14.2 the capital investment finance bill;
- 14.3 the commerce finance bill;
- 14.4 the education finance bill;
- 14.5 the early education finance bill;
- 14.6 the environment and natural resources bill;
- 14.7 the climate and energy finance bill;
- 14.8 the labor, industry, veterans and military affairs finance bill;
- 14.9 the health finance bill;
- 14.10 the human services finance bill;
- 14.11 the higher education finance bill;
- 14.12 the housing finance bill;
- 14.13 the jobs and economic development finance bill;
- 14.14 the judiciary finance bill;
- 14.15 the legacy finance bill;
- 14.16 the public safety and criminal justice reform finance bill;
- 14.17 the state government finance and elections bill;
- 14.18 the tax bill;
- 14.19 the transportation finance bill;

14.22 (f) After the adoption of a resolution by the Committee on Ways and Means, each finance  
 14.23 committee, and the Committee on Taxes must reconcile each bill described in Rule 4.10 with the  
 14.24 resolution. When reporting a finance or revenue bill, each committee or division must provide to  
 14.25 the Committee on Ways and Means a fiscal statement reconciling the bill with the resolution.

14.26 (g) After the adoption of a resolution by the Committee on Ways and Means, the Committee  
 14.27 on Ways and Means must reconcile finance and revenue bills with the resolution. When reporting  
 14.28 a bill, the chair of the Committee must certify to the House that the Committee has reconciled the  
 14.29 bill with the resolution.

14.30 (h) After the adoption of a resolution by the Committee on Ways and Means, an amendment  
 14.31 to a bill is out of order if it would cause any of the limits specified in the resolution to be exceeded.  
 14.32 Whether an amendment is out of order under this Rule is a question to be decided on the Floor by  
 14.33 the Speaker or other presiding officer and in Committee or Division by the person chairing the  
 14.34 Committee or Division meeting. In making the determination, the Speaker or other presiding officer  
 14.35 or the Committee or Division chair may consider: (1) the limits in a resolution; (2) the effect of

15.1 existing laws on revenues and expenditures; (3) the effect of amendments previously adopted to  
15.2 the bill under consideration; (4) the effect of bills previously recommended by a Committee or  
15.3 Division or bills previously passed in the legislative session by the House or by the legislature; (5)  
15.4 whether expenditure increases or revenue decreases that would result from the amendment are  
15.5 offset by decreases in other expenditures or increases in other revenue specified by the amendment;  
15.6 and (6) other information reasonably related to expenditure and revenue amounts.

15.7 (i) After a resolution is adopted by the Committee on Ways and Means, the Committee must  
15.8 make available a summary of the estimated fiscal effect on the general fund of each bill that has  
15.9 been referred to the Committee on Ways and Means by a finance committee or a division of a  
15.10 finance committee, or the Committee on Taxes and of each bill that has been reported by the  
15.11 Committee on Ways and Means.

15.12 4.05 AMENDMENT LIMITS. An amendment to a bill that has received its second reading  
15.13 and is being considered by the House is out of order if that amendment would increase the spending  
15.14 or spending base from any fund from which appropriations are made in that bill, or would increase  
15.15 the spending or spending base in total from all funds in the bill or in the bill with the proposed  
15.16 amendment. This rule is only in effect when a budget resolution adopted under Rule 4.03 is not in  
15.17 effect.

15.18 In the absence of an adopted budget resolution, this rule does not apply after the last Thursday  
15.19 on which the Legislature can meet in regular session in odd-numbered years, and after the last  
15.20 Thursday on which the Legislature intended, when it adopted the concurrent resolution required  
15.21 by Joint Rule 2.03, to meet in regular session in even-numbered years, or after a date specified by  
15.22 the Committee on Rules and Legislative Administration.

15.23 This provision does not apply when a Senate bill is accepted for substitution under Rule 1.15,  
15.24 or in the event that the language that was in the House version of the bill prior to a substitution  
15.25 under Rule 1.15, is adopted in its entirety as an amendment to a Senate file received by the House.

15.26 4.10 BILLS AFFECTING STATE REVENUES AND EXPENDITURES. (a) Except as  
15.27 provided in Rule 1.15, a House or Senate bill that directly, substantially, and specifically affects  
15.28 any present or future financial obligation, budget policy, or revenue of the State must be referred  
15.29 as provided in paragraphs (b) and (c) to the appropriate Committee before the bill receives its second  
15.30 reading. A bill that negligibly affects any present or future financial obligation, budget policy, or  
15.31 revenue of the State is not subject to mandatory referral under this rule.

15.32 (b) A bill subject to paragraph (a) reported by a finance committee must, if recommended to  
15.33 pass, be subsequently referred to the Ways and Means Committee, unless the bill has a negligible  
15.34 fiscal impact and is subject to direct reference to the Floor under Rule 6.05.

15.35 (c) A bill with a substantial impact on the tax revenues or tax policies of the State must be  
15.36 referred to the Committee on Taxes. A bill reported by the Committee on Taxes containing a  
15.37 substantial fiscal impact must be referred to the Committee on Ways and Means. For purposes of  
15.38 this paragraph, "tax" excludes any fee, charge, exaction, or assessment, a primary purpose of which

16.1 is to recover direct or indirect costs incurred by the state or other governmental entity or as a payment  
16.2 for benefits received.

16.3 (d) The chairs of the Committees on Taxes and Ways and Means shall advise the Speaker on  
16.4 the application of this rule and may determine whether or not any given piece of legislation must  
16.5 be referred to the committee they chair.

16.6 4.11 REVENUE BILLS TO ORIGINATE IN HOUSE. All bills for raising revenue shall  
16.7 originate in the House, but the Senate may propose and concur with the amendments as on other  
16.8 bills.

16.9 4.12 BILLS AFFECTING DEBT AND CAPITAL PROJECTS. The Committee on Capital  
16.10 Investment has jurisdiction over legislation affecting debt obligations issued by the state and capital  
16.11 projects of the state, including the planning, acquiring and bettering of public lands and buildings  
16.12 and other state projects of a capital nature. Except as provided in Rule 1.15, a House or Senate bill  
16.13 that directly and specifically affects debt obligations or capital projects of the state must be referred  
16.14 to the Committee on Capital Investment before the bill receives its second reading.

16.15 Referral is not required by this Rule if the bill deals primarily with the financing of state capital  
16.16 facilities using trunk highway funds, with transportation projects financed without debt obligations  
16.17 of the state, or with the local financing of capital facilities of local governments. Referral is not  
16.18 required by this Rule if the bill has a negligible effect on debt obligations and capital projects of  
16.19 the state as determined by the chair of the Committee on Ways and Means, in conjunction with the  
16.20 chair of the Committee on Capital Investment. Referral is not required by this Rule if the bill is a  
16.21 major finance or revenue bill identified in Rule 4.03, unless the bill directly and specifically affects  
16.22 debt obligations of the state, but if a major finance or revenue bill contains a provision that directly  
16.23 and specifically affects capital projects of the state, the chair of the finance or tax committee reporting  
16.24 the bill must notify the chair of the Committee on Ways and Means and the chair of the Committee  
16.25 on Capital Investment of the provision before the bill is considered by the House.

16.26 The Speaker, by announcement, must assign to each finance committee the appropriate  
16.27 jurisdiction for recommendations on debt obligations and capital projects of the state. Finance  
16.28 committees must submit recommendations within their jurisdiction to the Committee on Capital  
16.29 Investment for further disposition.

16.30 A bill with a fiscal effect reported by the Committee on Capital Investment must be accompanied  
16.31 by a statement of its fiscal effect, is exempt from the referral required by Rule 4.10, is subject to  
16.32 the same committee deadlines as the Committee on Ways and Means, and must be referred to the  
16.33 Committee on Ways and Means. This referral is not required if the bill has a negligible fiscal effect,  
16.34 as determined by the chair of the Committee on Capital Investment with the concurrence of the  
16.35 chair of the Committee on Ways and Means.

16.36 ~~4.13 BILLS AFFECTING STATE GOVERNMENT POWERS AND STRUCTURE. The~~  
16.37 ~~Committee on Government Operations and Elections Policy has jurisdiction over a House or Senate~~  
16.38 ~~bill that:~~



17.1 ~~(a) establishes or reestablishes a department, agency, commission, board, task force, advisory~~  
 17.2 ~~committee or council, or bureau, or other like entity;~~

17.3 ~~(b) delegates rulemaking authority to, or exempts from rulemaking, a department or agency of~~  
 17.4 ~~state government; or~~

17.5 ~~(c) substantially changes the organization of a department or agency of state government or~~  
 17.6 ~~substantially changes, vests or divests the official rights, powers, or duties of an official, department~~

17.8 ~~Except as otherwise provided in this Rule and Rule 1.15, a bill that is within the jurisdiction of~~

17.20 4.14 **BILLS PROPOSING MEMORIALS.** A bill or amendment that proposes to have a  
 17.21 memorial placed in the Capitol area must be referred to the Committee on Rules and Legislative  
 17.22 Administration.

17.23 4.15 **BILLS PROPOSING CONSTITUTIONAL AMENDMENTS.** A House or Senate bill  
 17.24 that proposes a constitutional amendment must be referred to the Committee on Rules and Legislative  
 17.25 Administration before it receives its second reading. When reporting such a bill, a committee or  
 17.26 division, other than the Committee on Rules and Legislative Administration, must recommend  
 17.27 re-referral to the Committee on Rules and Legislative Administration.

17.28 4.16 **BILLS AFFECTING GOVERNMENT DATA PRACTICES.** The Committee on Judiciary  
 17.29 Finance and Civil Law and Data Practices has jurisdiction over a House or Senate bill that  
 17.30 substantially affects either Minnesota Statutes, Chapter 13, or other government data practices  
 17.31 statutes. Except as otherwise provided in this Rule and Rule 1.15, a bill that is within the jurisdiction  
 17.32 of the Committee on Judiciary Finance and Civil Law and Data Practices must be referred to that  
 17.33 committee before it receives its second reading. A committee or division reporting such a bill must  
 17.34 recommend its re-referral to the Committee on Judiciary Finance and Civil Law and Data Practices  
 17.35 if reporting before the deadline for action on the bill by that committee; if reporting after the deadline,  
 17.36 the committee or division must recommend re-referral to the Committee on Rules and Legislative  
 17.37 Administration. The re-referral requirement of this Rule does not apply to a bill if the Committee  
 17.38 on Judiciary Finance and Civil Law and Data Practices already has approved the bill or the substance

18.1 of the matter that otherwise would require re-referral under this Rule. The Chair of the Committee  
18.2 on Judiciary Finance and Civil Law and Data Practices shall advise the Speaker on the application  
18.3 of this Rule and may determine whether or not a bill must be referred to the Committee under this  
18.4 Rule.

18.5 4.18 REFERRALS. Referral of a bill or a resolution to a subcommittee or division of a  
18.6 Committee is optional, and is determined by the Chair of the Committee.

18.7 4.20 DISPOSITION OF BILLS DURING INTERIM. Adjournment of the regular session in  
18.8 an odd-numbered year to a day certain in the next year is the same as daily adjournment except that  
18.9 a bill on the Calendar for the Day, Fiscal Calendar, or General Register must be returned to the  
18.10 standing committee or division that last acted on the bill.

18.11 4.30 RECALLING BILL FROM COMMITTEE OR DIVISION. A bill or resolution may be  
18.12 recalled from a committee or division at any time by majority vote of the whole House, be given  
18.13 a second reading and be placed on the General Register. A motion to recall a bill or resolution is  
18.14 in order only under the order of business "Motions and Resolutions." This Rule does not apply in  
18.15 a special session or after the deadline for committee reports on House files.

18.16 4.31 TIME LIMIT TO CONSIDER BILLS. If 20 legislative days after a bill has been referred  
18.17 to a committee or division (other than the Committee on Ways and Means, the Committee on Taxes,  
18.18 or a division of one of those committees) a report has not been made on it by the committee or  
18.19 division, its chief author may request that it be returned to the House. The request must be entered  
18.20 in the Journal.

18.21 The committee or division must vote on the bill requested within ten calendar days after the  
18.22 day of the request.

18.23 If the committee or division fails to vote on it within ten days, the chief author may present a  
18.24 written demand to the Speaker for its immediate return to the House. The demand must be presented  
18.25 within five calendar days after the day that the committee or division is required to vote. If the  
18.26 demand is presented in the time allowed, it must be entered in the Journal and is the demand of the  
18.27 House. The bill is then considered to be in the possession of the House and must be given its second  
18.28 reading and placed on the General Register.

18.29 The bill may be re-referred by a majority vote of the whole House. If the motion to re-refer is  
18.30 made on the day of the demand or on the next House legislative day, the motion takes precedence  
18.31 over all other motions except privileged motions and is in order at any time.

## 18.32 ARTICLE 5 - PARLIAMENTARY PRACTICE

18.33 5.01 SUSPENSION OR AMENDMENT OF THE RULES. The concurrence of two-thirds  
18.34 of the whole House is required to suspend or amend a Rule of the House, except that any amendment  
18.35 to the Rules reported by the Committee on Rules and Legislative Administration may be adopted  
18.36 by a majority of the whole House.

19.1 Except as provided in Rule 5.02, a motion to suspend or amend any Rule of the House must be  
 19.2 made under the order of business "Motions and Resolutions." If the motion is made at another time,  
 19.3 unanimous consent is required before the Speaker may entertain the motion.

19.4 A motion to suspend the Rules, together with the subject matter to which it pertains, is debatable,  
 19.5 but the previous question may be applied to the motion under Rule 3.13.

19.6 5.02 SUSPENSION OF RULES TO ADVANCE A BILL. A bill must be reported on three  
 19.7 different days as provided in Rule 1.04, except that in case of urgency, a two-thirds majority of the  
 19.8 whole House may suspend this requirement. A motion to suspend the Rules to advance a bill for  
 19.9 consideration out of its regular order is in order under the order of business "Motions and  
 19.10 Resolutions" or at any time the bill is before the House. The motion must be presented to the Speaker  
 19.11 in writing and must describe the status of the bill.

19.12 5.03 DEFINITIONS. In these Rules the terms "majority vote" and "vote of the House" mean  
 19.13 a majority of members present for the vote. The term "vote of the whole House" means a majority  
 19.14 of all the members elected to the House.

19.15 Singular words used in these Rules include the plural, unless the context indicates a contrary  
 19.16 intention.

19.17 5.04 AUTHORIZED MANUAL OF PARLIAMENTARY PROCEDURE. "Mason's Manual  
 19.18 of Legislative Procedure" governs the House in all applicable cases if it is not inconsistent with  
 19.19 these Rules, the Joint Rules of the Senate and House of Representatives, or established custom and  
 19.20 usage.

19.21 5.05 CONFLICT OF RULES. When there is a conflict between a single House Rule and a  
 19.22 single Joint Rule, the Speaker shall make a ruling as to which applies.

## 19.23 ARTICLE 6 - COMMITTEES, DIVISIONS, AND REPORTS

19.24 6.01 COMMITTEES AND DIVISIONS. Standing committees and divisions of the House  
 19.25 must be appointed by the Speaker as follows:

21.24 6.02 COMMITTEE, SUBCOMMITTEE, AND DIVISION MEMBERSHIP. At least 30 days  
 21.25 before the start of a regular session of the Legislature, the Speaker-designate must provide the  
 21.26 minority political party caucuses with a list of the standing committees, subcommittees, and divisions  
 21.27 proposed for the session. The Speaker-designate must prescribe the number of minority caucus  
 21.28 members to be appointed to each committee, subcommittee, and division and may require general  
 21.29 membership guidelines to be followed in the selection of committee, subcommittee, and division  
 21.30 members.

21.31 If the minority leader submits to the Speaker-designate, at least 15 days before the start of the  
 21.32 session, a list of proposed committee, subcommittee, and division assignments for the minority  
 21.33 caucus that complies with the numbers and guidelines provided, the Speaker must make the proposed  
 21.34 assignments with the purpose of attaining proportionate representation on the committees,  
 21.35 subcommittees, and divisions for the minority caucus.

22.1 A committee of the House must not have exclusive membership from one profession, occupation  
22.2 or vocation. Members of a subcommittee of a standing committee or division appointed by the  
22.3 Speaker need not have members exclusively from that standing committee or division.

22.4 A member must not serve as the chair of the same standing committee, subcommittee, or division,  
22.5 or a standing committee or division with substantially the same jurisdiction, during more than the  
22.6 three immediately prior consecutive regular biennial sessions. This Rule does not apply to service  
22.7 as chair of the Committee on Rules and Legislative Administration.

22.8 6.03 APPOINTMENTS TO BOARDS AND COMMISSIONS. Upon the convening of the  
22.9 biennial session, the Speaker must notify the members of the House of each board or commission  
22.10 to which a member of the House may be appointed by the Speaker. The Speaker must request advice  
22.11 from the minority leader on these appointments.

22.12 6.04 SUBCOMMITTEES. The chair of a committee or division must appoint the chair and  
22.13 members of each subcommittee with the advice and consent of the Speaker. The chair or the  
22.14 committee or division may refer bills to a subcommittee. A subcommittee may exercise the authority  
22.15 delegated to it by the chair or by the committee or division.

22.16 6.05 DIVISIONS. (a) If the Speaker or the House refers a bill to a division, the bill remains  
22.17 in that division until the House moves the bill from the division or approves a report from the  
22.18 division that moved the bill from that division. A division report under this paragraph is subject to  
22.19 Rule 6.30.

22.20 (b) The chair of a committee may refer a bill within the possession of the committee to a division  
22.21 of that committee. When the chair refers a bill to a division under this paragraph, the chair may  
22.22 recall the bill from the division. A committee chair referring or recalling a bill under this paragraph  
22.23 must give written notice of the referral or recall as soon as possible to the Chief Clerk for publication.  
22.24 To the extent practical, the Chief Clerk must attempt to provide notice on the House Web site of  
22.25 referrals and recalls of bills under this paragraph.

22.26 (c) The chair of a division must cause division records to be kept in a manner consistent with  
22.27 Rule 6.24.

22.28 (d) Division meetings are subject to Rule 6.20.

22.29 (e) Divisions are subject to Rule 6.21.

22.30 6.10 THE COMMITTEE ON ETHICS. The Speaker must appoint a Committee on Ethics  
22.31 consisting of four members: two members from the majority political party caucus, and two from  
22.32 the minority caucus. One alternate from each caucus must also be appointed. The committee must  
22.33 adopt written procedures, which must include due process requirements, for handling complaints  
22.34 and issuing guidelines.

22.35 A complaint may be brought about conduct by a member that violates a rule or administrative  
22.36 policy of the House, that violates accepted norms of House behavior, that betrays the public trust,  
22.37 or that tends to bring the House into dishonor or disrepute.

23.1 A complaint about a member's conduct must present with specificity the factual evidence  
23.2 supporting the complaint. A complaint must be in writing, under oath and signed by two or more  
23.3 members of the House, and submitted to the Speaker. Before submitting the complaint to the  
23.4 Speaker, the complainants must cause a copy of it and any supporting materials to be delivered to  
23.5 any member named in the complaint. Within seven days after receiving a complaint, the Speaker  
23.6 must refer the complaint to the Ethics Committee for processing by the committee according to its  
23.7 rules of procedure.

23.8 The existence and substance of a complaint, including any supporting materials, and all  
23.9 proceedings, meetings, hearings, and records of the Ethics Committee are public; except that the  
23.10 committee, upon a majority vote of the whole committee, may meet in executive session to consider  
23.11 or determine the question of probable cause, to consider a member's medical or other health records,  
23.12 or to protect the privacy of a victim or a third party.

23.13 A complaint of a breach of confidentiality by a member or employee of the House must be  
23.14 immediately referred by the Speaker to the Ethics Committee for disciplinary action.

23.15 The committee must act in an investigatory capacity and may make recommendations regarding  
23.16 complaints submitted to the Speaker before adjournment sine die. With the approval of the Speaker,  
23.17 the committee may retain a retired judge or other nonpartisan legal advisor to advise and assist the  
23.18 committee, as the committee considers appropriate and necessary in the circumstances of the case,  
23.19 in conducting the proceedings and obtaining a complete and accurate understanding of the  
23.20 information relevant to the conduct in question.

23.21 Ethics Committee recommendations for disciplinary action must be supported by clear and  
23.22 convincing evidence and must be reported to the House for final disposition.

23.23 6.20 COMMITTEE MEETING SCHEDULE; DEADLINES. The Speaker must prepare and  
23.24 publish a schedule of committee meetings, fixing as far as practicable the regular meeting day and  
23.25 time of each committee.

23.26 The chair of a committee must give written notice of a special meeting or a change in the regular  
23.27 schedule of meetings. The notice may be announced from the desk and must be posted in public  
23.28 notice locations maintained by the House. The notice must be posted at least one day in advance  
23.29 of the change.

23.30 As far as practicable, the chair of a committee must give three days notice of the date, time,  
23.31 place and agenda for each meeting.

23.32 Meeting notices must indicate when alternative media will be used to conduct the meeting.

23.33 During the first ten weeks of the session in the odd-numbered year and the first five weeks of  
23.34 the session in the even-numbered year, a standing committee must not have a regularly scheduled  
23.35 meeting after noon on Friday, but the Speaker may approve a special meeting of a committee during  
23.36 this time.

23.37 A committee must not meet between 12:00 midnight and 7:00 a.m.

24.1 Only the Committee on Rules and Legislative Administration may meet during a daily session  
24.2 of the House without leave.

24.3 The House shall establish deadlines for each regular session by resolution.

24.4 6.21 COMMITTEE PROCEDURES. Meetings of House committees must be open to the  
24.5 public except for executive sessions that the committee on ethics considers necessary under Rule  
24.6 6.10. For purposes of this requirement, a meeting occurs when a quorum is present and action is  
24.7 taken regarding a matter within the jurisdiction of the committee. This requirement does not apply  
24.8 to a meeting of members of a committee from the same political party caucus.

24.9 A majority of members of a committee is a quorum.

24.10 The Rules of the House must be observed in committee if they are applicable.

24.11 An amendment offered in committee must be on a subject that is within the jurisdiction of the  
24.12 committee. Whether an amendment is on a subject that is within the jurisdiction of the committee  
24.13 is a question to be decided by the person chairing the meeting, who may put the question to the  
24.14 committee.

24.15 A member of a committee may demand a roll call vote on any bill, resolution, report, motion  
24.16 or amendment before the committee. If a demand is made, the roll must be called. The name of the  
24.17 member demanding the roll call and the vote of each member must be recorded in the committee  
24.18 minutes.

24.19 A committee may reconsider an action while the matter remains in the possession of the  
24.20 committee. A committee member need not have voted with the prevailing side to move to reconsider  
24.21 the action.

24.22 The chair of a committee, after consultation with the Speaker, may establish written procedures  
24.23 for the submission of amendments to the committee, the setting of committee agendas, and other  
24.24 matters pertaining to the conduct of the committee's business. Before implementing the written  
24.25 procedures, the chair must provide a copy of them to the Speaker and to each member of the House  
24.26 and must make copies available to others upon request.

24.27 6.22 PUBLIC TESTIMONY. Public testimony from proponents and opponents must be  
24.28 allowed on every bill or resolution before a standing committee, division or subcommittee of the  
24.29 House.

24.30 6.23 OPEN MEETING ENFORCEMENT. A person may submit to the Speaker a complaint  
24.31 alleging a violation of the open meeting requirements of Rule 6.21. The complaint must be in  
24.32 writing. On receiving a complaint, the Speaker, or a person designated by the Speaker, must  
24.33 investigate the complaint promptly. If the Speaker concludes, following investigation, that a violation  
24.34 of the open meeting Rule may have occurred, the Speaker must refer the complaint to the Committee  
24.35 on Ethics for further proceedings.

24.36 6.24 COMMITTEE RECORDS. The chair of a standing committee must cause a committee  
24.37 record to be kept, in the form prescribed by the Committee on Rules and Legislative Administration.



25.1 The record must include the record of committee proceedings on each bill referred to the committee  
25.2 and the minutes of the committee and any subcommittees.

25.3 The committee and subcommittee minutes must include:

25.4 a. the time and place of each hearing or meeting;

25.5 b. the names of committee or subcommittee members who are present;

25.6 c. the name and address, at the Chair's discretion, of each person appearing before the committee  
25.7 or subcommittee, together with the name and address of the person, association, firm or corporation  
25.8 in whose behalf the appearance is made;

25.9 d. the language of each motion, the name of the member making the motion, the result of a vote  
25.10 on the motion, and, on a roll call vote, the names of those in favor and those opposed;

25.11 e. the date on which a subcommittee is established, the names of its members and the file number  
25.12 of bills referred to it and reported by it;

25.13 f. other important matters related to the work of the committee or subcommittee.

25.14 The minutes must be approved at the next regular meeting of the committee or subcommittee.

25.15 At the end of two business days after approval by the committee or subcommittee, copies of  
25.16 the minutes must be filed with the Chief Clerk and be open to public inspection in the Chief Clerk's  
25.17 office and on the House Web site.

25.18 At the end of the legislative biennium minutes and other records must be delivered to the Director  
25.19 of the Legislative Reference Library.

25.20 Audio recordings of Committee and Subcommittee meetings must be made available for public  
25.21 use by the end of the business day following each meeting. The chair of a committee who elects  
25.22 not to release the recording of a committee meeting until the minutes of the meeting are approved  
25.23 by the committee must make a copy of the recording available by the end of the next business day  
25.24 after a written request for it is made to the committee. The House must keep the recordings of  
25.25 committee meetings available for public use during the legislative biennium in which they were  
25.26 created and, at the end of the legislative biennium, must transmit a copy of the recordings to the  
25.27 Director of the Legislative Reference Library.

25.28 The Legislative Reference Library must keep committee records and recordings available for  
25.29 public use under its rules for eight years after the end of the legislative biennium during which the  
25.30 materials were created and then may preserve or dispose of the recordings as the Library sees fit.

25.31 A person may obtain a copy of a recording during the legislative biennium in which it is created  
25.32 by paying a fee determined by the House Controller to cover the cost of preparing the copy. A  
25.33 person may obtain a copy of a recording while it is kept in the Library by paying a fee determined  
25.34 by the House Controller to cover the cost of preparing the copy. A person may obtain a copy of a  
25.35 page of committee minutes or other records for a fee determined by the House Controller to cover  
25.36 the cost of preparing the copy. A copy of a recording must be provided free to a member or staff  
25.37 of the House upon request for use in legislative business.

26.1 Testimony and discussion preserved under this Rule are not intended to be admissible in a court  
26.2 or administrative proceeding on an issue of legislative intent.

26.3 6.30 COMMITTEE REPORTS. The House must adopt or reject a committee report on a bill  
26.4 or resolution without amendment.

26.5 The chair of a standing committee reporting to the House on a bill or resolution must use the  
26.6 form provided for committee reports. Each bill or resolution must be reported separately. The report  
26.7 must state the action taken by the committee and the date of the action. The report must be  
26.8 authenticated by the signature of the chair.

26.9 Before a committee reports favorably on a bill or resolution, the chair must see that the form  
26.10 of the bill or resolution conforms to these Rules and the Joint Rules of the House and Senate.

26.11 Except during the last seven legislative days in a year, the committee report and any minority  
26.12 report must be submitted to the Chief Clerk at least four hours before the convening of the daily  
26.13 session. The Committee on Rules and Legislative Administration may report at any time.

26.14 6.31 SUBSTITUTION OF BILLS. A standing or special committee or division or its members  
26.15 must not report a substitute for a bill referred to the committee or division if the substitute relates  
26.16 to a different subject, is intended to accomplish a different purpose, or requires a title essentially  
26.17 different from that of the bill referred. If the House is advised that a substitute bill reported to the  
26.18 House violates this Rule, the report must not be adopted.

26.19 6.32 MINORITY REPORTS. A minority report must be made separately from the majority  
26.20 report and must be considered before the majority report. If the minority report is adopted the  
26.21 majority report must not be considered. If the minority report is not adopted the majority report  
26.22 must then be considered.

26.23 6.40 REPORTS OF CONFERENCE COMMITTEES. A conference committee may report  
26.24 at any time and may meet during a daily session of the House without leave. A conference committee  
26.25 report must be electronically available or printed.

26.26 A conference committee report must include only subject matter contained in the House or  
26.27 Senate versions of the bill for which that conference committee was appointed, or like subject  
26.28 matter contained in a bill passed by the House or Senate. The member presenting the conference  
26.29 committee report to the House must disclose all substantive changes from the House version of the  
26.30 bill.

26.31 6.50 COMMITTEE OR DIVISION REPORT LAID OVER. The report of any committee or  
26.32 division may be laid over one day and printed in the Journal, if so ordered by the House.

## 26.33 ARTICLE 7 - OFFICERS OF THE HOUSE

26.34 7.01 DUTIES AND PRIVILEGES OF THE SPEAKER. The Speaker must preside over the  
26.35 House and has all the powers and duties of the presiding officer.

26.36 The Speaker must preserve order and decorum. The Speaker may order the lobby or galleries  
26.37 cleared in the case of disorderly conduct or other disturbance.

27.1 Except as otherwise provided by rule or law, the Speaker has general control of the Chamber  
27.2 of the House and of the corridors, passages and rooms in the Capitol and State Office Building  
27.3 under the jurisdiction of the House.

27.4 The Speaker must sign all acts, addresses, joint resolutions, writs, warrants and subpoenas of  
27.5 the House or issued by order of the House. The Speaker must sign all abstracts for the payment of  
27.6 money from funds appropriated by the Legislature to the House; but money must not be paid unless  
27.7 the abstract is also signed by the Controller of the House. Abstracts for compensation of members  
27.8 must be signed by the Chief Clerk pursuant to law.

27.9 The Speaker must appoint the Chief Sergeant at Arms or must designate that officer from among  
27.10 the Sergeants at Arms elected by the House or appointed by the Committee on Rules and Legislative  
27.11 Administration.

27.12 When an elected office of the House becomes vacant, the Speaker must designate a person to  
27.13 exercise the powers and discharge the duties of the office as necessary until a successor is elected  
27.14 by the House.

27.15 7.02 SUCCESSOR IN OFFICE OF SPEAKER. When the office of Speaker becomes vacant,  
27.16 the Chair of the Committee on Rules and Legislative Administration has the powers and must  
27.17 discharge the duties of the office as necessary, until a Speaker is elected by the House or until a  
27.18 speaker-designate is selected as provided in this Rule. The House must elect a Speaker when the  
27.19 House is next called to order. If the Legislature is not in session, within 30 days after the office of  
27.20 Speaker becomes vacant the Committee on Rules and Legislative Administration must meet and  
27.21 select a speaker-designate to exercise the powers and discharge the duties of the office as necessary  
27.22 until a Speaker is elected by the House.

27.23 7.05 SPEAKER PRO TEMPORE. The Speaker must appoint one or more members as Speaker  
27.24 pro tempore. A Speaker pro tempore must preside in the Speaker's absence. In the absence of the  
27.25 Speaker and a Speaker pro tempore, a member selected by the Speaker must preside until the  
27.26 Speaker or Speaker pro tempore returns.

27.27 7.06 SPEAKER EMERITUS. Any current member having served the House in the capacity  
27.28 of Speaker will, subsequent to that service, be known as Speaker Emeritus, and may perform such  
27.29 ceremonial functions and duties as assigned by the Speaker.

27.30 7.10 DUTIES OF CHIEF CLERK. The Chief Clerk has general supervision of all clerical  
27.31 duties pertaining to the business of the House. The Chief Clerk must perform, under the direction  
27.32 of the Speaker, all the duties of the office of Chief Clerk. The Chief Clerk must keep records showing  
27.33 the status and progress of all bills, memorials and resolutions.

27.34 During a temporary absence of the Chief Clerk, the First Assistant Chief Clerk has all the usual  
27.35 responsibilities of the Chief Clerk and may sign the daily journal, enrollments, abstracts and other  
27.36 legislative documents.

28.1 The Chief Clerk must supervise the engrossment and enrollment of bills. The Chief Clerk must  
28.2 see that a record is kept, by file number, of the bills introduced in the House that passed both houses  
28.3 and are enrolled.

28.4 The Chief Clerk must ensure that locations accessible to the public are available to post a list  
28.5 of committee and subcommittee meetings and any other announcements or notices the House may  
28.6 require.

28.7 The Index Clerk, supervised by the Chief Clerk, must prepare an index in which bills may be  
28.8 indexed by topic, number, author, subject, section of the statutes amended, committees, divisions,  
28.9 and any other method that will make it a complete and comprehensive index.

28.10 The index must be open for public inspection during the legislative session and must be printed  
28.11 in the permanent Journal.

28.12 7.20 DUTIES OF THE SERGEANT AT ARMS. The Sergeant at Arms must carry out all  
28.13 orders of the House or the Speaker and perform all other services pertaining to the office of Sergeant  
28.14 at Arms, including: maintaining order in the Chamber and other areas used for the business of the  
28.15 House and its committees and divisions and members; supervising the entering and exiting from  
28.16 the Chamber and the other areas; and promptly delivering messages.

## 28.17 ARTICLE 8 - ADMINISTRATION OF THE HOUSE

28.18 8.01 BUDGET AND FINANCIAL AFFAIRS. The House Controller must prepare a biennial  
28.19 budget for the House. The budget must be approved by the Committee on Rules and Legislative  
28.20 Administration before it is submitted to the State Government Finance Committee. By the 15th day  
28.21 of April, July, October, and January of each year, the Controller must submit a detailed report of  
28.22 House expenditures during the previous quarter to the Speaker and the Committee on Rules and  
28.23 Legislative Administration.

28.24 The House Controller must arrange for the purchase of goods and services for the House. The  
28.25 Controller must seek the lowest possible prices consistent with satisfactory quality and dependability.  
28.26 A contract of the House, or an amendment to a contract, authorizing an expenditure of more than  
28.27 \$500 must be signed by the Speaker or the Controller. A contract, or an amendment to a contract,  
28.28 authorizing an expenditure of up to \$500 may be executed by an employee authorized and directed  
28.29 in writing by the Controller to act for the Controller on the contract or contracts of its type. A  
28.30 contract or amendment to a contract entered into in violation of this Rule is not binding on the  
28.31 House. The House Controller must consult with an adaptive technology expert to identify  
28.32 commercially available upgrades for computers and Internet technology that are compatible with  
28.33 adaptive speech technology prior to purchasing upgrades.

28.34 Employees of the House must be reimbursed for actual expenses in the same manner as state  
28.35 employees.

29.1 During session, for travel away from the Capitol, members must be reimbursed for actual  
29.2 expenses, in addition to per diem expense allowances, in the manner and amount prescribed by the  
29.3 Committee on Rules and Legislative Administration.

29.4 8.02 MEMBER OFFICES. Members not seeking re-election are required to vacate their House  
29.5 offices by December 1 of their last year of service. Members who are not re-elected are required  
29.6 to vacate their House offices by December 15 of their last year of service. The Sergeants Office  
29.7 will arrange usable space for these members after their offices are vacated, if requested to do so,  
29.8 and shall accommodate all serving members in the event of a special session.

29.9 8.10 COMMITTEE AND DIVISION BUDGETS AND EXPENSES. The Committee on  
29.10 Rules and Legislative Administration must establish a budget for each standing committee and  
29.11 division of the House for expenses incurred by the committee or division, its members, and its staff  
29.12 in conducting its legislative business. Per diem expense allowances paid to members during sessions  
29.13 or at times set by the Speaker or the Committee on Rules and Legislative Administration must not  
29.14 be charged against the budget. A committee or division must not incur expenses in excess of its  
29.15 authorized budget.

29.16 All charges against the committee or division budget must be approved by the chair before  
29.17 payment is made.

29.18 8.20 APPOINTMENT OF EMPLOYEES. The Committee on Rules and Legislative  
29.19 Administration must designate the position of and appoint each employee of the House and set the  
29.20 compensation of each officer and employee. A record of the appointments, including positions and  
29.21 compensation, must be kept in the office of the House Controller and must be available for inspection  
29.22 by the public.

29.23 The Committee on Rules and Legislative Administration must establish the procedure for filling  
29.24 employment vacancies when the Legislature is not in session.

29.25 An employee of the House may be assigned to other duties, suspended or discharged at any  
29.26 time by the Committee on Rules and Legislative Administration.

29.27 8.30 LEGAL REPRESENTATION. An employee of the nonpartisan House Research  
29.28 Department may not represent the House or its members as counsel of record, in a judicial or  
29.29 administrative proceeding.

## 29.30 ARTICLE 9 - CONDUCT

29.31 9.01 CODE OF CONDUCT. The Committee on Rules and Legislative Administration, after  
29.32 receiving the recommendation of the Committee on Ethics, must establish and maintain a code of  
29.33 conduct for members, officers and employees of the House.

29.34 9.05 CAMPAIGN ACTIVITIES. An employee of the House must not participate in campaign  
29.35 activity during working hours. An employee must not be obliged to participate in campaign activities  
29.36 as a condition of employment. A member is not an employee of the House for purposes of this

30.1 Rule. House equipment must not be used for campaign activities. The Committee on Rules and  
 30.2 Legislative Administration must define the terms of and implement this Rule.

30.3 9.10 SOLICITATIONS DURING LEGISLATIVE SESSION. During regular or special  
 30.4 session, a member of the House, a political party caucus, the member's principal campaign committee,  
 30.5 a political committee with the member's name or title, or a committee authorized by the member  
 30.6 that benefits the member, must not solicit or accept a contribution from a registered lobbyist,  
 30.7 corporation, labor union, political committee, dissolving principal campaign committee, political  
 30.8 fund, or a tribal organization.

30.9 A member must not accept compensation for lobbying.

30.10 9.20 ACCEPTANCE OF AN HONORARIUM BY A MEMBER. A member must not accept  
 30.11 an honorarium for a service performed for an individual or organization that has a direct interest  
 30.12 in the business of the House, including, but not limited to, a registered lobbyist or an organization  
 30.13 a lobbyist represents. The term "honorarium" does not include reimbursement for expenses incurred  
 30.14 and actually paid by a member in performing a service.

30.15 Alleged violations of this Rule must be referred to the Committee on Ethics under Rule 6.10.  
 30.16 If the Committee on Ethics finds that an honorarium was accepted in violation of this Rule, the  
 30.17 Committee must direct its return. If it is not returned, the committee may recommend disciplinary  
 30.18 action under Rule 6.10.

30.19 9.21 ACCEPTANCE OF TRAVEL AND LODGING BY A MEMBER OR EMPLOYEE. A  
 30.20 member or employee of the House must not accept travel or lodging from any foreign government,  
 30.21 private for-profit business, labor union, registered lobbyist, or an association thereof, except payment  
 30.22 permitted by law of expenses that relate to the member's or employee's participation as a legislator  
 30.23 or legislative employee in a meeting or conference. This Rule does not apply to travel or lodging  
 30.24 provided to a member in the regular course of the member's employment or business.

30.25 9.30 DENIAL OF COMPENSATION WHILE DETAINED. A member must not receive  
 30.26 compensation, mileage, or living expenses while the member is incarcerated or on home detention  
 30.27 due to a criminal conviction.

30.28 9.35 BAN ON LOBBYING. Former state legislators must not register as lobbyists within  
 30.29 one year from the date they leave office.

30.30 9.40 NO SMOKING IN HOUSE AREAS. Smoking is prohibited in the areas of the Capitol  
 30.31 and State Office Building under the jurisdiction of the House, including the House Chamber and  
 30.32 Retiring Room and galleries, hearing rooms, minor corridors and offices, private offices, and  
 30.33 lounges.

#### 30.34 ARTICLE 10 - EMERGENCY HOUSE OPERATIONS

30.35 10.01 EMERGENCY HOUSE OPERATIONS. (a) ~~During the peacetime emergency declared~~  
 30.36 ~~by the Governor on March 13, 2020, in Executive Order 20-01, or during any other peacetime~~  
 30.37 ~~emergency related to infectious disease COVID-19 declared by the Governor pursuant to Minnesota~~

31.1 ~~Statutes, section 12.31 prior to January 31, 2021,~~ The Minnesota House of Representatives may  
31.2 allow floor and committee procedures related to member debate and voting to occur by means of  
31.3 distance voting, remote electronic voting, or voting by other means designed to allow legislative  
31.4 operations while preserving the safety of the public, staff, and members.

31.5 (b) Use of distance voting, remote electronic voting, or voting by other means under paragraph  
31.6 (a) may only occur at the direction of the Speaker of the House after consultation with the minority  
31.7 leader and majority leader, must be used only to protect the health and safety of the public, staff,  
31.8 and members, and must cease once doing so is no longer necessary to protect the health and safety  
31.9 of the public, staff, and members.

31.10 (c) Committee meetings held by alternate means must provide the public with an opportunity  
31.11 to provide testimony.

31.12 (d) Rule 10.01 sunsets the day following the last day of the 92nd Regular Session.
