- 2.2 (6) masonry veneer; and

- 2.4 (c) **Carpentry.** Carpentry includes work in any of the following areas:
 - 2.5 (1) rough framing;
 - 2.6 (2) finish carpentry;
 - 2.7 (3) doors, windows, and skylights;
 - 2.8 (4) porches and decks, excluding footings;
 - 2.9 (5) wood foundations; and
 - 2.10 (6) drywall installation, excluding taping and finishing.
- 2.11 (d) **Interior finishing.** Interior finishing includes work in any of the following areas:
 - 2.12 (1) floor covering;
 - 2.13 (2) wood floors;
 - 2.14 (3) cabinet and counter top installation;
 - 2.15 (4) insulation and vapor barriers;
 - 2.16 (5) interior or exterior painting;
 - 2.17 (6) ceramic, marble, and quarry tile;
 - 2.18 (7) ornamental guardrail and installation of prefabricated stairs; and
 - 2.19 (8) wallpapering.
- 2.20 (e) **Exterior finishing.** Exterior finishing includes work in any of the following areas:
 - 2.21 (1) siding;
 - 2.22 (2) soffit, fascia, and trim;
 - 2.23 (3) exterior plaster and stucco;
 - 2.24 (4) painting; and
 - 2.25 (5) rain carrying systems, including gutters and down spouts.
- 2.26 (f) **Drywall and plaster.** Drywall and plaster includes work in any of the following
- 2.27 areas:

- 3.1 (1) installation;
- 3.2 (2) taping;
- 3.3 (3) finishing;
- 3.4 (4) interior plaster;
- 3.5 (5) painting; and
- 3.6 (6) wallpapering.
- 3.7 (g) **Residential roofing.** Residential roofing includes work in any of the following areas:
- 3.8 (1) roof coverings;
- 3.9 (2) roof sheathing;
- 3.10 (3) roof weatherproofing and insulation;
- 3.11 (4) repair of roof support system, but not construction of new roof support system; and
- 3.12 (5) penetration of roof coverings for purposes of attaching a solar photovoltaic system.
- 3.13 (h) **General installation specialties.** Installation includes work in any of the following
- 3.14 areas:
- 3.15 (1) garage doors and openers;
- 3.16 (2) ~~pools~~, spas; and hot tubs;

- 3.19 (5) ornamental guardrail and prefabricated stairs; and
