| 1.8 | Section 1. Minnesota Statutes 2022, section 201.014, is amended by adding a subdivision |
| 1.9 | to read: |
| 1.10 | Subd. 2a. Felony conviction; restoration of civil right to vote. An individual convicted |
| 1.11 | of a felony has the civil right to vote restored when the individual is no longer incarcerated |
| 1.12 | for the offense, or upon sentencing if no incarceration is imposed. If the individual is later |
| 1.13 | incarcerated for the same offense, the individual's civil right to vote is lost only during the |
| 1.14 | period of incarceration. |
| 1.15 | Sec. 2. Minnesota Statutes 2022, section 201.071, subdivision 1, is amended to read: |
| 1.16 | Subdivision 1. Form. Both paper and electronic voter registration applications must |
| 1.17 | contain the same information unless otherwise provided by law. A voter registration |
| 1.18 | application must contain spaces for the following required information: voter's first name, |
| 1.19 | middle name, and last name; voter's previous name, if any; voter's current address; voter's |
| 1.20 | previous address, if any; voter's date of birth; voter's municipality and county of residence; |

- 2.12 (5) am not under court-ordered guardianship in which the court order revokes my right
 2.13 to vote;
- 2.14 (6) have not been found by a court to be legally incompetent to vote;

- 2.25 "If you checked 'no' to either of these questions, do not complete this form."
- 2.26 The form of the voter registration application and the certification of voter eligibility
- 2.27 must be as provided in this subdivision and approved by the secretary of state. Voter
- 2.28 registration forms authorized by the National Voter Registration Act must also be accepted
- 2.29 as valid. The federal postcard application form must also be accepted as valid if it is not
- 2.30 deficient and the voter is eligible to register in Minnesota.

4.1 (b) At the presidential nomination primary, the polling place roster must also state: "I

4.2 am in general agreement with the principles of the party for whose candidate I intend to

4.3 vote." This statement must appear separately from the statements required in paragraph (a).

4.4 The felony penalty provided for in paragraph (a) does not apply to this paragraph.

4.5 (c) A judge may, before the applicant signs the roster or voter signature certificate,
4.6 confirm the applicant's name, address, and date of birth.

4.7 (d) After the applicant signs the roster or voter signature certificate, the judge shall give
4.8 the applicant a voter's receipt. The voter shall deliver the voter's receipt to the judge in
4.9 charge of ballots as proof of the voter's right to vote, and thereupon the judge shall hand to
4.10 the voter the ballot. The voters' receipts must be maintained during the time for notice of
4.11 filing an election contest.

4.12 (e) Whenever a challenged status appears on the polling place roster, an election judge
4.13 must ensure that the challenge is concealed or hidden from the view of any voter other than
4.14 the voter whose status is challenged.

4.16 <u>Subdivision 1.</u> Correctional facilities; designation of official. The chief executive

4.17 officer of each state and local correctional facility shall designate an official within the

4.18 facility to provide the notice and application required under this section to a person to whom

4.19 <u>the civil right to vote is restored by reason of the person's release from actual incarceration.</u>

4.20 <u>The official shall maintain an adequate supply of voter registration applications and</u>

4.21 informational materials for this purpose.

4.22 <u>Subd. 2.</u> Notice requirement. A notice of restoration of the civil right to vote and a 4.23 voter registration application must be provided as follows:

- 4.24 (1) the chief executive officer of each state and local correctional facility shall provide
 4.25 the notice and application to a person being released from the facility following incarceration
- 4.26 for a felony-level offense; and

4.27 (2) a probation officer or supervised release agent shall provide the notice and application 4.28 to all individuals under correctional supervision for a felony-level offense.

- 4.29 Subd. 3. Form of notice. The notice required by subdivision 2 must appear substantially
- 4.30 <u>as follows:</u>

4.31 **"NOTICE OF RESTORATION OF YOUR RIGHT TO VOTE.**

| 5.12 | to all civil rights and to full citizenship, with full right to vote and hold office, the same as |
| 5.13 | if such conviction had not taken place, and the order of discharge shall so provide. |

5.15 This act is effective July 1, 2023, and applies to the right to vote at elections conducted 5.16 <u>on or after that date.</u>
