

# Emerald Ash Borer Activities and Updates: 2/5/2021

### \$700,000 General Fund: Preparing for Emerald Ash Borer in Community Forests

The Minnesota Department of Natural Resources received 51 applications for a total of \$3,373,575 requested. The grant was open to any local government in Minnesota. Eligible activities include conducting a tree inventory, developing a management plan that includes an EAB component, and tree and stump removal and tree replacement. In total, \$679,000.00 was allocated to communities and \$21,000 went to grant administration.

Communities have indicated they need more time to complete projects. This appropriation needs an extension.

## \$300,000 LCCMR: Emerald Ash Borer Community Forest Response Tree Planting

DNR received 25 applications with a total of \$625,435.29 requested. The grant was open to any local government in Minnesota. Eligible activities included tree planting and associated needs. All \$300,000.00 allocated to communities.
