1.2 Page 6, after line 20, insert:

1.3 "Sec. 9. CONVEYANCE OF SURPLUS STATE LAND; REDWOOD COUNTY.

1.4 (a) Notwithstanding Minnesota Statutes, sections 16B.281 to 16B.298, or any other law
1.5 to the contrary, upon approval by the Minnesota Historical Society's Executive Council,
1.6 the director of the Minnesota Historical Society may convey to the Lower Sioux Indian
1.7 Community in the state of Minnesota, for no consideration, the surplus land and real property
1.8 that is described in paragraph (c).

1.9 (b) The Minnesota Historical Society may make necessary changes to the legal description
1.10 to correct errors and ensure accuracy.

1.11 (c) The land to be conveyed is located in Redwood County and is described as: TRACT
1.12 "C" that part of the Northeast Quarter of the Northwest Quarter of Section 8, Township 112,
1.13 Range 34, Redwood County, Minnesota, lying southerly of the center line of C.S.A.H. NO.
1.14 2 as shown on REDWOOD COUNTY RIGHT OF WAY PLAT NO. 3 C.S.A.H. NUMBER
1.15 2 as of public record, Redwood County, Minnesota.

1.16 (d) The Minnesota Historical Society has determined that the state's land management
1.17 interests and interpretive program interests would best be served if portions of the Lower
1.18 Sioux Agency Historic Site were conveyed to the Lower Sioux Indian Community in the
1.19 state of Minnesota."

1.20 Page 8, after line 16, insert:

1.21 "Sec. 13. CONVEYANCE OF SURPLUS STATE LAND; WASHINGTON COUNTY.

1.22 (a) Notwithstanding Minnesota Statutes, sections 16B.281 to 16B.298, or any other law
1.23 to the contrary, upon approval by the Minnesota Historical Society's Executive Council,

2.1 the director of the Minnesota Historical Society may convey to the city of Marine on Saint
2.2 Croix, for no consideration, the surplus land and real property that is described in paragraph
2.3 (c).

2.4 (b) The Minnesota Historical Society may make necessary changes to the legal description
2.5 to correct errors and ensure accuracy.

2.6 (c) The land to be conveyed is located in Washington County and is described as: that
2.7 part of Block 47 of MARINE, according to the recorded plat thereof, Washington County,
2.8 Minnesota, described as follows: Commencing at the southwest corner of said Block 47,
2.9 thence North 24 degrees 18 minutes 37 seconds West, assumed bearing, along the westerly
2.10 line of said Block 47, a distance of 98.35 feet, to the point of beginning of the tract of land
2.11 to be described; thence continuing North 24 degrees 18 minutes 37 seconds West, along
2.12 said westerly line of Block 47, a distance of 61.38 feet; thence North 66 degrees 16 minutes
2.13 53 seconds East, 89.81 feet; thence South 24 degrees 27 minutes 39 seconds East, 59.63
2.14 feet; thence South 65 degrees 09 minutes 47 seconds West, 89.96 feet, to the point of
2.15 beginning."
