Vice-Chair Agbaje moved the minutes of April 22nd, 2026, be approved. **THE MOTION PREVAILED.**

HF1082 (Moller)– Public safety; time extended to use appropriations; sale or transfer of a law enforcement vehicle, assault of hospital or clinic security guard, and grooming prohibited; crimes of impersonating a peace officer and theft modified; task forces and grant program established; MINNCOR policies modified; domestic violence cases process modified; criminal penalties provided; reports required; and money appropriated.

Representative Moller moved that HF1082 be placed on the General Register.

Chair Torkelson moved the HF1082A15 amendment. **THE AMENDMENT WAS ADOPTED.**

Chair Torkelson moved the H1082A16 amendment. **THE AMENDMENT WAS ADOPTED.**

Representative Moller renewed the motion that HF1082, as amended, be placed on the General Register. **THE MOTION PREVAILED.**

HF4252 (Wolgamott) – Student aid reporting requirements modified; additional accommodations for parenting students required; American Indian Scholars program eligibility modified; provisions modified related to private career schools, private and out-of-state postsecondary institutions, unemployment insurance aid, and developmental courses; prior appropriations modified; and reports required. **HF4252 is the Higher Education Supplemental Finance Bill.**

Chair Torkelson moved that HF4252 be placed on the General Register.

Chair Torkelson moved the HF4252A18 amendment. **THE AMENDMENT WAS ADOPTED.**

Chair Torkelson renewed the motion that HF4252, as amended, be placed on the General Register. **THE MOTION PREVAILED.**
