We are Doctors for Early Childhood, advocating for babies and toddlers and their families. We are 3 pediatricians and a Doctor of Education. We favor HF367 as a further step toward healthier children, families, and other caregivers. There are many reports of measles outbreaks, even in the US. Measles is not a mild childhood illness. Its vaccine was developed to prevent a severe form of measles-caused brain infection (encephalitis), which left victims permanently impaired if not dead.

The COVID 19 Pandemic disrupted usual avenues for childhood immunizations, leaving many children of all circumstances behind in their vaccines. Preventing the spread of Measles and other vaccine preventable diseases is so important and getting babies and children up to date will save lives, prevent impairments, and prevent the spread to others whose immune systems may not be as spry, or not yet complete in their vaccine series.

As childcare owners, we would like to offer our strong support to HF367. Why?

- We serve children under the age that can't be fully vaccinated. These children need our protection. Their parents expect them to be safe in our care.
- We had a child diagnosed with leukemia recently. He is only 3 years old. He deserves our protection.
- Recently, a measles outbreak was reported in nearby Dakota county. This is a potential life and death decision that an independent business needs to be able to handle in a way that allows them to safeguard the children in our care.

Additionally, this bill is fair. It does not mandate anything. It simply allows us flexibility, as a business that serves very young vulnerable children, to decide how to handle vaccinations. In a time when it seems every issue has a winner and loser this bill produces only winners. Children can be protected from disease – ultimately the winner that most matters. We are a licensed Child Care Center and Montessori school operating for the past 7 years since June 2017 in Maple Grove.

As a licensed child care provider, I strongly support the bills SF610 and HF367 because providers should be able to make their own policies with regards to immunizations.

It is widely recognized that the children who are not vaccinated, can transmit vaccine-preventable diseases at child care centers. Unvaccinated children can infect babies who are too young to be fully immunized, and can also infect people of any age who can't be immunized for medical reasons, which includes children and adults with leukemia and other cancers, immune system problems, and people of all ages receiving treatments or medications that suppress their immune systems (See https://dhhs.ne.gov/Immunization/Whatifyoudontimmunizeyourchild.pdf)



Dear Members of the House Children and Families Finance and Policy Committee,

On behalf of the more than 10,000 members of the Minnesota Medical Association (MMA), I am writing in support of HF 367, to offer child care centers providers the chance to offer an increased level of health protection in their programs.

According to the Centers for Disease Control and Prevention, the proportion of U.S. kindergartners receiving state-required vaccines — for illnesses such as polio, measles, mumps, rubella, and diphtheria — declined from 95% to approximately 93% nationwide. Minnesota's kindergartners have immunization rates below the national average. According to a report from the Minnesota Department of Health from the 2022-2023 school year, only 89% of kindergartner students entering public school were fully vaccinated.

This is an extremely concerning decline.

HF 367 aims to reverse that decline. Most childhood vaccinations and boosters occur between 2 months of age and 2 years of age. By removing the non-medical exemption for child care centers and family child care programs, the rates of fully vaccinated children in our communities will increase.

There have been reports of existing cases of measles this year in Minnesota already. Measles is highly contagious and can be extremely serious, especially in young populations. More Minnesotans need to be vaccinated against measles, and this bill will go far to help reach that end.

HF 367 is a step in the right direction for the health and wellbeing of all Minnesotans. Vaccines save lives and — as has been demonstrated over and over — they are safe. I urge members to support HF 367.

To whom it may concern:

My name is Nicole Flick, and I am in support of this bill as a licensed child care center provider in Minnesota. I have been working in the Early Childhood field for 19 years, owning my center for 8 years. This bill (HF367-SF610) allows the provider to use their best judgment when it comes to immunizations and the children in their care.

When you ask a provider what the worst thing that could happen to a child under their care, the answer would be a communicable disease outbreak, even before death. The liability on all the other children in your care versus the one, has to take precedent.

I have been through this scenario, I had a parent who chose not to vaccinate and she called me one day and told me she "thinks her child has measles" I instantly went into survival mode letting all my parents know and getting on the phone with the MN Department of Health. In this instance the only thing I could do to prevent all my little infants from attracting the disease was to "watch them for symptoms". By this time my parents were furious I had allowed this to happen (I was just following the religious exemption law), and several terminated care that same day, I lost thousands of dollars in monthly tuition. Turned out it was not measles but hand, foot and mouth which the doctor got wrong as this family didn't see a licensed physician, they sought out a naturopathist. Thankfully, it was only a small virus, but still all my infants attracted it and were still out for a week.

As a provider who lives this life day in and day out, we need to be able to make sure the children in our care are safe from diseases that could kill them and the parents enrolling their children expect us to keep their child safe. Parents have every right to enroll their child in any program they see fit. However, I as the provider should have the right to choose if I want to take the risk of having unvaccinated children in the same building as infants whose parents cannot yet vaccinate due to age. The risk to young infants who cannot be immunized and attracting a disease like measles could not only create a new pandemic but the death toll would be outright dangerous and preventable.

We all know the science behind vaccines. We all also understand the parents' right to religion and their choice on how to raise their children. However, when their choice can affect how other children live or die, we have to be real. I should have rights as a private care provider as well, within the laws of course.

Fully funding childcare would give the state the right to keep this law, however since there are no plans to do that, we are private small businesses, not schools.

Dear Chair Pinto and Committee Members,

My name is Joe Piket and I own and operate two Primrose Schools in Maple Grove and Brooklyn Park. I enthusiastically support HF367. To me, this bill is about two things: business freedom and protecting children.

Private businesses should be able to decide on their own customer policies while weighing risks and rewards. Current immunization law should never have included private childcare businesses – we don't enjoy the same protections as public entities. If we have an outbreak parents will turn to me and want to know why I didn't take additional steps to protect their children. I serve infants under 12 to 15 months of age, children who are too young to have received certain vaccines such as for measles. I want to be able to do more to protect the children in my care.

Since this bill only creates a choice for providers, there will still be childcare programs that accept personal belief exemptions. There also need to be places for families who do not want or cannot afford to take this risk with their own children, and want the assurance of a program that does not allow this exemption.

In the end, this bill is about who gets to make choices. Parents can choose to use personal belief exemptions, but private businesses should be able to make decisions around that as well. Everyone should get the same opportunity.
