Representative Tabke presented HF4353, as amended.

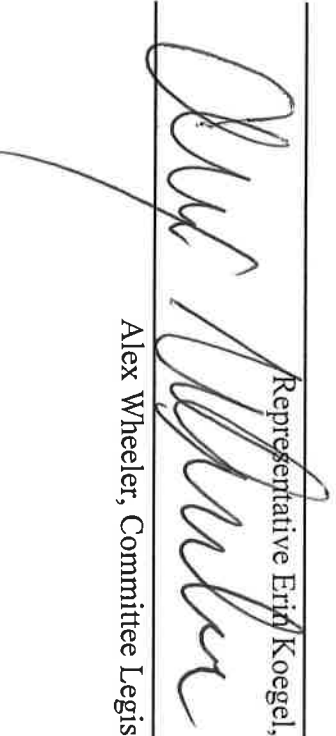
