Chair Baker moved that HF 3732, as amended, to be re-referred to the Ways and Means Committee. THE MOTION PREVAILED

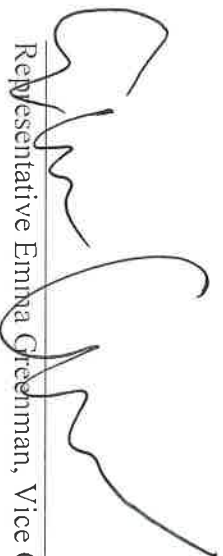
