3.15 ~~education, and Board of Trustees of the Minnesota State Colleges and Universities. The~~
3.16 ~~report shall contain a financial report for the preceding year.~~

3.17 ~~(b) If established, the State~~ The Concurrent Enrollment Teacher Partnership must submit
3.18 an annual joint report to the legislature and the Office of Higher Education by January 15
3.19 of each year on the progress of its activities. The report must include the number of teachers
3.20 participating in the program, the geographic location of the teachers, the number of credits
3.21 earned, and the subject areas of the courses in which participants earned credit. The report
