1.3 Insurance Marketplace shall contract with the commissioner of commerce"

1.4 Page 8, line 1, after "Marketplace" insert "that satisfy but do not exceed federal
1.5 certification requirements under the Affordable Care Act (Public Law 111-148), as long as
1.6 doing so does not violate existing state law,"

1.7 Page 8, line 7, after "satisfy" insert ", but do not exceed,"

1.8 Page 8, line 8, after "Marketplace" insert ", as long as doing so does not violate
1.9 existing state law"

1.10 Page 8, line 9, delete everything after "board" and insert "shall allow any health
1.11 carrier and health benefit plans that have met certification requirements to participate"

1.12 Page 8, line 10, delete "participation" and delete everything after "Marketplace"
1.13 and insert a period

1.14 Page 8, delete lines 11 and 12

1.15 Page 8, before line 13, insert:

1.16 "(c) The Minnesota Insurance Marketplace shall contract with the commissioner of
1.17 commerce to review the justification for any premium increases as required by section
1.18 1311(e)(2) of the federal Patient Protection and Affordable Care Act (Public Law 111-148).
1.19 In carrying out these requirements, the commissioner of commerce shall apply the same
1.20 standard and process used to review insurance plan premium rates under section 62A.02."
