1.20 (2) not pregnant;

1.21 (3) not entitled to Medicare Part A or enrolled in Medicare Part B under Title XVIII
1.22 of the Social Security Act;

1.23 (4) not an adult in a family with children as defined in section 256L.01, subdivision
1.24 3a; and

2.1 (5) not described in another subdivision of this section.

2.4 Subd. 1a. **Income and assets generally.** (a) Unless specifically required by state
2.5 law or rule or federal law or regulation, the methodologies used in counting income and
2.6 assets to determine eligibility for medical assistance for persons whose eligibility category
2.7 is based on blindness, disability, or age of 65 or more years, the methodologies for the
2.8 supplemental security income program shall be used, except as provided under subdivision
2.9 3, paragraph (a), clause (6). Increases in benefits under title II of the Social Security Act
2.10 shall not be counted as income for purposes of this subdivision until July 1 of each year.

2.11 (b) Effective upon federal approval, for children eligible under section 256B.055,
2.12 subdivision 12, or for home and community-based waiver services whose eligibility
2.13 for medical assistance is determined without regard to parental income, child support
2.14 payments, including any payments made by an obligor in satisfaction of or in addition
2.15 to a temporary or permanent order for child support, and Social Security payments are

3.15 Subd. 3. **Asset limitations for individuals and families.** (a) To be eligible for
3.16 medical assistance, a person must not individually own more than \$3,000 in assets, or if a
3.17 member of a household with two family members, husband and wife, or parent and child,
3.18 the household must not own more than \$6,000 in assets, plus \$200 for each additional
3.19 legal dependent. In addition to these maximum amounts, an eligible individual or family
3.20 may accrue interest on these amounts, but they must be reduced to the maximum at the
3.21 time of an eligibility redetermination. The accumulation of the clothing and personal
3.22 needs allowance according to section 256B.35 must also be reduced to the maximum at
3.23 the time of the eligibility redetermination. The value of assets that are not considered in
3.24 determining eligibility for medical assistance is the value of those assets excluded under
3.25 the supplemental security income program for aged, blind, and disabled persons, with
3.26 the following exceptions:

3.27 (1) household goods and personal effects are not considered;

3.28 (2) capital and operating assets of a trade or business that the local agency determines
3.29 are necessary to the person's ability to earn an income are not considered;

3.30 (3) motor vehicles are excluded to the same extent excluded by the supplemental
3.31 security income program;

3.32 (4) assets designated as burial expenses are excluded to the same extent excluded by
3.33 the supplemental security income program. Burial expenses funded by annuity contracts

4.32 the federal poverty guidelines. Effective January 1, 2000, and each successive January,
4.33 recipients of supplemental security income may have an income up to the supplemental
4.34 security income standard in effect on that date.

5.2 up to 133-1/3 percent of the AFDC income standard in effect under the July 16, 1996,
