2.18 grant administration, standards, and criteria as provided under subdivision 6, including  
2.19 bridge specifications, in cooperation with road authorities of political subdivisions, for use  
2.20 in the administration of funds appropriated to the commissioner and for the administration  
2.21 of grants to subdivisions.

2.22 (b) The maximum use of standardized bridges is encouraged. Regardless of the size  
2.23 of the existing bridge, a bridge or replacement bridge is eligible for assistance from the  
2.24 state transportation fund if a hydrological survey indicates that the bridge or replacement  
2.25 bridge must be ten feet or more in length.

2.26 (c) As part of the standards or rules, the commissioner shall, in consultation with  
2.27 local road authorities, establish a minimum distance between any two bridges that cross
