1.8 issued valid license from another state, or ~~is enrolled in either:~~

1.9 (i) the applicant is enrolled in behind-the-wheel training in a public, private, or
1.10 commercial driver education program that is approved by the commissioner of public
1.11 safety; and

1.12 (ii) the applicant:

1.13 (A) has completed the classroom phase of instruction in a public, private, or
1.14 commercial driver education program that is approved by the commissioner of public
1.15 safety and that includes classroom and behind-the-wheel training; or,

1.16 ~~(ii) an approved behind-the-wheel driver education program~~ (B) has completed
1.17 home school driver training, when the student is receiving full-time instruction in a home
1.18 school within the meaning of sections 120A.22 and 120A.24, the student is working

1.20 certified by the superintendent of the school district in which the student resides, and the

2.7 is living or, if items (i) to (iii) do not apply, then (iv) the guardian having custody of the

2.10 or guardian, or is married or otherwise legally emancipated, then (vi) the applicant's
