

1.1 moves to amend S.F. No. 856, the second unofficial engrossment, as follows:

1.2 Page 22, delete section 20 and insert:

1.3 "Sec. 20. APPROPRIATIONS.

1.4 Subdivision 1. **Inspector general.** \$2,742,000 in fiscal year 2027 is appropriated from
1.5 the general fund to the Office of the Inspector General for purposes of this act. The base
1.6 for this appropriation is \$7,474,000 in fiscal year 2028 and \$7,474,000 in fiscal year 2029.
1.7 The commissioner of administration, in consultation with the commissioner of management
1.8 and budget, may transfer amounts in fiscal year 2027 to the commissioner of administration
1.9 for office build out, cost of space, office equipment, and other costs directly related to the
1.10 establishment of the office.

1.11 Subd. 2. **Administration.** \$892,000 in fiscal year 2027 is appropriated from the general
1.12 fund to the commissioner of administration to establish the Office of the Inspector General.
1.13 The base for this appropriation is \$892,000 in fiscal year 2028 and \$0 in fiscal year 2029.

1.14 Subd. 3. **Children, youth, and families.** \$465,000 in fiscal year 2027 is appropriated
1.15 from the general fund to the commissioner of children, youth, and families to coordinate
1.16 with the Office of the Inspector General as required under this act. The base for this
1.17 appropriation is \$620,000 in fiscal year 2028 and \$620,000 in fiscal year 2029.

1.18 Subd. 4. **Education.** \$589,000 in fiscal year 2027 is appropriated from the general fund
1.19 to the commissioner of education to coordinate with the Office of the Inspector General as
1.20 required under this act. The base for this appropriation is \$785,000 in fiscal year 2028 and
1.21 \$785,000 in fiscal year 2029.

1.22 Subd. 5. **Health.** \$499,000 in fiscal year 2027 is appropriated from the general fund to
1.23 the commissioner of health to coordinate with the Office of the Inspector General as required
1.24 under this act.

2.1 Subd. 6. **Human services.** \$2,721,000 in fiscal year 2027 is appropriated from the general
2.2 fund to the commissioner of human services to coordinate with the Office of the Inspector
2.3 General as required under this act. The base for this appropriation is \$3,204,000 in fiscal
2.4 year 2028 and \$3,204,000 in fiscal year 2029.

2.5 Subd. 7. **Labor and industry.** \$27,000 in fiscal year 2027 is appropriated from the
2.6 workers compensation fund to the commissioner of labor and industry to coordinate with
2.7 the Office of the Inspector General as required under this act.

2.8 Subd. 8. **Legislature.** \$29,000 in fiscal year 2027 is appropriated from the general fund
2.9 to the executive director of the Legislative Coordinating Commission to support the
2.10 Legislative Inspector General Advisory Commission. The base for this appropriation is
2.11 \$7,000 in fiscal year 2028 and \$7,000 in fiscal year 2029."
