1.5 Subd. 8. **Development, evaluation, and peer coaching for continuing contract**  
1.6 **teachers.** (a) To improve student learning and success, a school board and an exclusive  
1.7 representative of the teachers in the district, consistent with paragraph (b), may develop  
1.8 a teacher evaluation and peer review process for probationary and continuing contract  
1.9 teachers through joint agreement. If a school board and the exclusive representative of the  
1.10 teachers do not agree to an annual teacher evaluation and peer review process, then the  
1.11 school board and the exclusive representative of the teachers must implement the plan  
1.12 for evaluation and review under paragraph (c). The process must include having trained  
1.13 observers serve as peer coaches or having teachers participate in professional learning  
1.14 communities, consistent with paragraph (b).
