1.4 "Sec. ... Minnesota Statutes 2012, section 256.969, subdivision 29, is amended to read:

1.5 Subd. 29. **Reimbursement for the fee increase for the early hearing detection**  
1.6 **and intervention program.** (a) For admissions occurring on or after July 1, 2010,  
1.7 payment rates shall be adjusted to include the increase to the fee that is effective on July 1,  
1.8 2010, for the early hearing detection and intervention program recipients under section  
1.9 144.125, subdivision 1, that is paid by the hospital for public program recipients. This  
1.10 payment increase shall be in effect until the increase is fully recognized in the base year  
1.11 cost under subdivision 2b. This payment shall be included in payments to contracted  
1.12 managed care organizations.

1.13 (b) For admissions occurring on or after July 1, 2013, payment rates shall be  
1.14 adjusted to include the increase to the fee that is effective July 1, 2013, for the early  
1.15 hearing detection and intervention program recipients under section 144.125, subdivision

1.23 Subd. 3a. **Support services to families.** The commissioner shall contract with a  
1.24 nonprofit organization to provide support and assistance to families with children who are  
1.25 deaf or have a hearing loss. The family support provided must include:

2.1           (1) direct hearing loss specific parent-to-parent assistance and unbiased information  
 2.2 on communication, educational, and medical options, preferably provided by a program  
 2.3 that is part of a national organization; and

2.4           (2) individualized deaf or hard of hearing mentors who provide education, including  
 2.5 instruction in American Sign Language.

2.6 The commissioner shall give preference to a nonprofit organization that has the ability to  
 2.7 provide these services throughout the state."

2.9 "Newborn screening. \$121,000 in fiscal
