1.9	licensure, except that the board may issue a temporary, one-year teaching license to an

1.22	(d) The board must provide the leadership and adopt rules for the redesign of teacher

2.1 122A.245, among other programs, must include a content-specific, board-approved,
2.2 performance-based assessment that measures teacher candidates in three areas: planning

(e) The board must adopt rules requiring candidates for initial licenses to pass an 2.5 examination of general pedagogical knowledge and examinations of licensure-specific 2.6 teaching skills. The rules shall be effective by September 1, 2001. The rules under this 2.7 paragraph also must require candidates for initial licenses to teach prekindergarten or 2.8 elementary students to pass, as part of the examination of licensure-specific teaching 2.9 skills, test items assessing the candidates' knowledge, skill, and ability in comprehensive, 2.10 scientifically based reading instruction under section 122A.06, subdivision 4, and their 2.11 knowledge and understanding of the foundations of reading development, the development 2.12 of reading comprehension, and reading assessment and instruction, and their ability to 2.13 integrate that knowledge and understanding. 2.14

2.15 (f) The board must adopt rules requiring teacher educators to work directly with
2.16 elementary or secondary school teachers in elementary or secondary schools to obtain
2.17 periodic exposure to the elementary or secondary teaching environment.

(g) The board must grant licenses to interns and to candidates for initial licenses
based on appropriate professional competencies that are aligned with the board's licensing
system and students' diverse learning needs. The board must include these licenses in a
statewide differentiated licensing system that creates new leadership roles for successful
experienced teachers premised on a collaborative professional culture dedicated to meeting
students' diverse learning needs in the 21st century and formalizes mentoring and induction
for newly licensed teachers that is provided through a teacher support framework.

(h) The board must design and implement an assessment system which requires a
candidate for an initial license and first continuing license to demonstrate the abilities
necessary to perform selected, representative teaching tasks at appropriate levels.

2.28 (i) The board must receive recommendations from local committees as established2.29 by the board for the renewal of teaching licenses.

(j) The board must grant life licenses to those who qualify according to requirements
established by the board, and suspend or revoke licenses pursuant to sections 122A.20 and
2.32 214.10. The board must not establish any expiration date for application for life licenses.

(k) The board must adopt rules that require all licensed teachers who are renewing
their continuing license to include in their renewal requirements further preparation in
the areas of using positive behavior interventions and in accommodating, modifying, and

adapting curricula, materials, and strategies to appropriately meet the needs of individual
students and ensure adequate progress toward the state's graduation rule.

- 3.3 (1) In adopting rules to license public school teachers who provide health-related
