2.4 (a) \$4,488,000 in fiscal year 2013 is appropriated from the clean water fund to the
2.5 Board of Regents of the University of Minnesota for research on aquatic invasive species
2.6 that threaten or have the potential to threaten the state's lakes, rivers, and streams. With
2.7 the approval of the Board of Regents of the University of Minnesota, the appropriation
2.8 shall fund the following within the College of Food, Agricultural and Natural Resource
2.9 Sciences' Department of Fisheries, Wildlife and Conservation Biology:

2.10 (1) three research assistant professors with three different focus areas, to include
2.11 environmental DNA, zebra mussels, and fish ecology;

2.12 (2) one postdoctoral position focused on zebra mussels;

2.13 (3) one program or laboratory manager;

2.14 (4) one fish care technician;

2.15 (5) five graduate students within the Department of Fisheries, Wildlife and
2.16 Conservation Biology; and

2.17 (6) up to \$1,050,000 in equipment necessary for the research activities under this
2.18 paragraph.

2.19 (b) This is a onetime appropriation and is available until June 30, 2018.

2.20 (c) Money appropriated in this section may not be spent on activities unless they
2.21 are directly related to and necessary for the appropriation. Money appropriated in this
2.22 section must not be spent on indirect costs or other institutional overhead charges that are
2.23 not directly related to and necessary for the appropriation."
