1.6 **commissioner.** Unless the commissioner has entered into an agreement under subdivision
1.7 2a or subdivision 2b, the commissioner shall administer and enforce the State Building
1.8 Code as a municipality with respect to public buildings and state licensed facilities in the
1.9 state. The commissioner shall establish appropriate permit, plan review, inspection fees,

2.6 **for all building projects.** (a) The commissioner shall enter into an agreement with a
2.7 municipality other than the state for plan review, inspection, code administration, and
2.8 code enforcement on public buildings and state licensed facilities in the jurisdiction if
2.9 the municipality requests to provide those services and the commissioner determines
2.10 that the municipality has enough adequately trained and qualified inspectors to provide
2.11 those services. In determining whether a municipality has enough adequately trained and
2.12 qualified inspectors to provide the service, the commissioner must consider all inspectors
2.13 that are employed by the municipality, are under contract with the municipality to provide
2.14 inspection services, or are obligated to provide inspection services to the municipality
2.15 under any other lawful agreement.

2.16 (b) The criteria used to make this determination shall be provided in writing to
2.17 the municipality requesting an agreement.

2.18 (c) If the commissioner determines that the municipality lacks enough adequately
2.19 trained and qualified inspectors to provide the required services, a written explanation of
2.20 the deficiencies shall be provided to the municipality.

2.21 (d) The municipality shall be given an opportunity to remedy any deficiencies
2.22 and request reconsideration of the commissioner's determination. A request for
2.23 reconsideration must be in writing and accompanied by substantiating documentation. A
2.24 request for reconsideration must be received by the commissioner within 90 days of the
2.25 determination explanation. The commissioner shall review the information and issue a
2.26 final determination to the municipality within 30 days of the request.

3.4 (1) roof covering replacement that does not add roof load;

3.5 (2) towers requiring special inspection;

3.6 (3) single-level storage buildings not exceeding 5,000 square feet;

3.7 (4) exterior maintenance work, including replacement of siding, windows, and doors;

3.8 (5) HVAC unit replacement that does not add roof load or ventilation capacity;

3.9 (6) accessibility upgrades not involving building additions or structural alterations;

3.10 (7) remodeling that does not change the building's occupancy, structural system, exit
3.11 access or discharge pattern, or mechanical load; and

3.12 (8) other projects determined to be reserved by the commissioner.
