1.2 (H2294DE2), as follows:

1.3 Page 4, after line 31, insert:

1.4 "Sec. Minnesota Statutes 2011 Supplement, section 256B.69, subdivision 5c,
1.5 is amended to read:

1.6 Subd. 5c. **Medical education and research fund.** (a) The commissioner of human
1.7 services shall transfer each year to the medical education and research fund established
1.8 under section 62J.692, ~~an amount specified in this subdivision. The commissioner shall~~
1.9 ~~calculate~~ the following:

1.10 (1) an amount equal to the reduction in the prepaid medical assistance payments as
1.11 specified in this clause. Until January 1, 2002, the county medical assistance capitation
1.12 base rate prior to plan specific adjustments and after the regional rate adjustments under
1.13 subdivision 5b is reduced 6.3 percent for Hennepin County, two percent for the remaining
1.14 metropolitan counties, and no reduction for nonmetropolitan Minnesota counties; and after
1.15 January 1, 2002, the county medical assistance capitation base rate prior to plan specific
1.16 adjustments is reduced 6.3 percent for Hennepin County, two percent for the remaining
1.17 metropolitan counties, and 1.6 percent for nonmetropolitan Minnesota counties. Nursing
1.18 facility and elderly waiver payments and demonstration project payments operating
1.19 under subdivision 23 are excluded from this reduction. The amount calculated under
1.20 this clause shall not be adjusted for periods already paid due to subsequent changes to
1.21 the capitation payments;

1.22 (2) beginning July 1, 2003, \$4,314,000 from the capitation rates paid under this
1.23 section;

1.24 (3) beginning July 1, 2002, an additional \$12,700,000 from the capitation rates
1.25 paid under this section; and

1.26 (4) beginning July 1, 2003, an additional \$4,700,000 from the capitation rates paid
1.27 under this section.

2.1 (b) This subdivision shall be effective upon approval of a federal waiver which
2.2 allows federal financial participation in the medical education and research fund. The
2.3 amount specified under paragraph (a), clauses (1) to (4), shall not exceed the total amount
2.4 transferred for fiscal year 2009. Any excess shall first reduce the amounts specified under
2.5 paragraph (a), clauses (2) to (4). Any excess following this reduction shall proportionally
2.6 reduce the amount specified under paragraph (a), clause (1).

2.7 (c) Beginning September 1, 2011, of the amount in paragraph (a), the commissioner
2.8 shall transfer \$21,714,000 each fiscal year to the medical education and research fund.

2.9 (d) ~~Beginning September 1, 2011,~~ Of the amount in paragraph (a), and following
2.10 the transfer under paragraph (c), the commissioner shall transfer to the medical education
2.11 research fund \$23,936,000 in fiscal ~~years~~ year 2012 ~~and 2013~~ and \$36,744,000 in fiscal
2.12 year ~~2014 and thereafter~~ 2013.
